#### CALL TO ORDER/PLEDGE OF ALLEGIANCE/PUBLIC ANNOUNCEMENT

This regular meeting of the Alpine Zoning Board of Adjustment was called to order by Chairman Glazer at 7:30 p.m., Thursday, August 18, 2022 at the Alpine Borough Hall, the Pledge of Allegiance recited and the Public Announcement read according to the requirements of N.J.S.A. 10:4-6 et seq.:

## **OATHS/SWEARING IN CEREMONY:**

At the Mayor and Council meeting held on May 25, 2022, Mr. Robert F. Policano was appointed as Alternate Member II of the Zoning Board of Adjustment.

Tonight, Mayor Tomasko administered the OATH of Office to affirm the appointment of Robert F. Policano as Alternate Member II of the Alpine Zoning Board of Adjustment for the unexpired potion of a two-year term ending December 31, 2023.

#### **COMMUNICATIONS**

- Mayor Tomasko communicated that Larry Shadek sold his house and can no longer serve as Councilman. David
  Kupferschmid will join as Councilman officially next Wednesday at the Mayor and Council meeting, replacing
  Larry Shadek. The Mayor and Chairman Glazer recognized Mr. Kupferschmid for his time and contributions as he
  has served this zoning board for the past 18+ years.
- Amy Lerner is entitled to become a full Board Member; Robert Policano will then move up as Alternate I Member. The Mayor to provide another appointment for an Alternate II Member.
- Mayor Tomasko stated that tax bills are in the mail. It is noteworthy that residents will be paying less taxes next
  year than this year. Not many towns get to see this: School numbers came out lower, county came out flat and
  our tax equalization ratio went up. This is indicative of the hard work by the Mayor and Council and borough staff.
- Mr. Policano expressed admiration for Mayor Tomasko. He stated that the Mayor did an outstanding job at the last Mayor and Council meeting; bringing in professionals to summarize the affordable housing situation and alleviated a lot of questions beforehand. He is proud to be a part of this town.
- Bergen County Board of Health has provided 300 Free Covid-19 antigen test kits for our residents. Anyone interested can pick up one kit per household in the Borough Clerk's office while supplies last.
- Matthew Capizzi requested to adjourn the following hearings: 1) Church of the Lord (they are required to renotice since it has been over 90 days), and 2) Dorf (notice required), to September 18, 2022.
