Spring Cleanup Time Is Here!!!!!

One week only—dates above. Place all items at the curb by 7:00 AM on designated pickup days. Items can't exceed 5 foot dimensions or 50 lbs. weight. Put small items in disposable boxes and secure with string or strong tape. Do not include recyclable items. These must be put out separately for collection by the DPW.

Computer & Electronics Recycling: Computers, keyboards, monitors, printers, VCRs, TV sets, stereo equipment, phone equipment, cell phones, copiers, fax machines, etc. Place these in a separate pile at the curb for DPW pickup. During the remainder of the year drop off at the designated area behind Borough Hall.

Special Recyclables/White Goods: Stoves, refrigerators/freezers (**REMOVE DOORS**), washing machines, dishwashers, iron boilers, car tires, car batteries. Place separately at curb for DPW pick up during spring cleanup week or call the DPW at 201-784-2900 ext. 50 to schedule a pickup appointment during the year.

<u>Please be patient if you see all or some items left behind. Different trucks pick up different items and delays may</u> occur based on volume. Rest assured all eligible items will be picked up by week's end.

DO NOT PUT OUT: Garbage, building refuse, construction debris, yard waste, dirt, stones, stumps, concrete, etc. or **Household Hazardous Waste** items such as paints, chemicals, oils, flammable liquids, and hazardous materials. To safely dispose of these items, please see the BCUA Household Waste Collection dates below:

FREE RECYCLE COACH APP

The Borough of Alpine has signed up with Recycle Coach, a service offered by the NJDEP to all governments free of charge. The app will set up a personalized garbage and recycling calendar with reminders and allows users to find local disposal information for thousands of household items. It's available on every device, including Amazon Alexa and Google Assistant. The app can be downloaded from the App Store and Google Play. After inputting an address into the app, users will receive recycling information customized to where they live, including collection and event schedules, a database explaining what is and isn't recyclable, important communications, educational content, recycling quizzes and more.

STORMWATER MANAGEMENT



Protect our water supplies: Washing your car, fertilizing the lawn, pesticide applications, tossing litter and not cleaning up after pets all contribute to water pollution. Prevent chemicals from spilling onto the ground, right of ways, streets and into catch basins. Use drop cloths. Choose eco friendly car soaps and lawn treatments. Don't litter. Clean up after pets. RECYCLING REMINDERS

Curbside Recycling 2022 Recycling Magnets are available in the Clerk's office (while supplies last) and the schedule is also posted on the Recycling page of the Borough website. Recycling is mandatory in Alpine. Rinse glass, tin, aluminum and plastics until clean. Co-mingled cans, plastic and glass are picked up the 1st & 3rd Wednesday of the month. Paper and flattened cardboard are picked up the 2nd & 4th Wednesday of the month. Please keep recyclables dry and secured from the elements. The vendor will not return for items put out later than 6 AM or put out incorrectly. If you feel your recyclables were put out correctly and on time but they were not picked up, contact Buldo Carting at 201-666-4344. If you still have questions or concerns notify the Borough Clerk's office at 201-784-2900 ext. 10 or 19.

PLACE YOUR RECYCLEABLES AT THE CURB EITHER THE NIGHT BEFORE OR NO LATER THAN 6:00 AM THE MORNING OF SCHEDULED PICKUP

Having Work Done? Recycling is Required. Pickup Recycling Report forms at the same time you or your contractor pick up permits for tree removal, demolition, construction or septic work with tree removal. Your contractor (on your behalf) must report the tonnage or cubic yardage of all solid waste and eligible recyclable materials removed from the site, provide weight receipts and identify the end market(s) where the materials are being taken, which must be NJ Class B or C Recycling facilities capable of separating out recyclable materials. A list of appropriate end markets can be found in in the Bergen County Recycling Market

Directory on the Bergen County Utilities Authority website (bcua.org). If recycling wood chips on site, these too must be measured and reported. Eligible items include trees, tree parts, stumps, concrete, asphalt, masonry, asphalt roof shingles, metals, white goods, cardboard and clean (not processed) wood products. Please remind workers to clean-up their personal litter and recycle soda cans and bottles, too. Together we can reduce what goes into landfills.
