COMMENTS FROM THE BOARD:

- Ms. Herries inquired about commitments made in the resolution for this applicant.
- Mr. Kates replied that the memorialization does not stop them from resolving issues surrounding this application and they cannot obtain a CCO until they fulfil conditions.
- Mr. Glazer commented that one of the attorneys conducted an aerial view of the site and 750 square feet may not address coverage requirements.
- Board Secretary commented that the Board Engineer cannot conduct site inspections until funds are replenished in the escrow.
- Ms. Herries confirmed that only Board Members that voted in favor can vote for the memorialization.
- Mr. Kates offered the Board additional time to review the draft resolution until the next Zoning Board meeting.

- Church of the Lord has not submitted a Final As-Built Survey. We are also awaiting additional escrow funds in order to pay bills. Mr. Kates recommended not to release permits and CCO's until we receive escrow.
