**COMMUNICATIONS**

- Mayor Tomasko provided updates and reported on the following:
  - On Memorial Day, the DPW set up 110 chairs at The Rock but there were still not enough chairs. We had a full-fledged parade and the programs for the children at Borough Hall was very well attended.
  - The Swim Club already has 45 members with over 10 out of town memberships which garners higher fees.
  - Alpine school graduation is scheduled for next Tuesday at 5pm and at Tenafly next Wednesday at 6pm.
  - Primary election was last Tuesday and the Mayor thanked those that came out to vote. Two Council seats up for re-election with no competition, and one new candidate running against Mayor Tomasko in November.
  - There are a lot of repercussions from recent storm events on Anderson Avenue in Closter. This is not the first time we are experiencing storm water run-off from higher ground and run-off from one property to another. We are meeting to deal with drainage infrastructure and storm drain maintenance issues.
  - Newsletter will be out this month.
- Board Secretary communicated the following updates:
  - Received request from Mr. Matthew Capizzi's office to adjourn Church of Lord hearing to August 18, 2022. They will need to re-notice since it will be over 90 days.
  - In new business, Stephen & Barbara Dorf hearing is tentatively scheduled for August 18, 2022; Matthew Capizzi is the attorney for this applicant as well. Engineer review letter received on June 14 and packets will be prepared for the Board to review as soon as plans are received, and confirmation of notices have been sent and published.
  - At the Mayor and Council meeting held on Wednesday, May 25, 2022, Robert F. Policano was appointed as Alternate Member II of the Zoning Board of Adjustment and is scheduled to be sworn in on July 21<sup>st</sup> Zoning Board meeting. No scheduled hearings in July; only the usual order of business approving tonight's meeting minutes, possibly some bills and swearing in of the new appointment to the Board.

Chairman Glazer announced that the July 21 meeting will be suspended due to no new business or hearings that are scheduled for July, and Robert F. Policano will be sworn in at the next Zoning Board meeting scheduled for August 18, 2022.
