**CALL TO ORDER/PUBLIC ANNOUNCEMENT:** Dr. Laifer called the meeting to order at 7:00 p.m. and read the following Public Announcement in compliance with the N.J.S.A. 10:4-6 et seq.: *In accordance with the provisions of the New Jersey Open Public Meetings Law, the notice of this Regular Meeting held Tuesday, February 10, 2015 has met the requirements of the law by being faxed to The Record and posted on the bulletin board of the lobby in the Borough Hall and a copy filed in the office of the Borough Clerk.*

**OATHS OF OFFICE:** were administered by Mayor Paul Tomasko.

**Dr. Basil Dalavagas** was administered the oath of office for a four year term as Member expiring December 31, 2018.

**Mary Ellen Snow** was administered the oath of office for the unexpired portion of a four term expiring December 31, 2016.

**Anthony Inguaggiato, Sr.** was administered the oath of office for the unexpired portion of a two year term expiring December 31, 2015.

Dr. Penn had advised he could not attend and will be administered his oath at the next meeting.

**Registrar of Vital Statistics: Nancy Wehmann** Upon motion by Dr. Laifer, seconded by Dr. Gasalberti to affirm the appointment as Registrar of Vital Statistics retroactive to February 1, 2015 at an annual salary per the salary ordinance. This appointment is for the unexpired portion of a three year term expiring 1/31/2017 vacated by the resignation of Mr. Beckmann effective February 1, 2015. Ms. Wehmann to obtain Certified Municipal Registrar certification within 6 months of appointment. Approved by all. The Oath of Office was administered by Mayor Tomasko.

## **BUSINESS:**

**Stigma-Free Campaign: A Collaborative Campaign Against the Stigma of Mental Illness in Bergen County.** Dr. Laifer recognized Mayor Tomasko who wished to advise the Board of a presentation he attended this morning at the Bergen County League of Municipalities Mayors' Breakfast that included representatives from Bergen County including Health Department Director, Dr. Nancy Mangieri and the County Executive. The presentation focused on the Stigma-Free Campaign and copies of the handouts received were provided to the Board. Mayor Tomasko advised the goal is to focus attention and get the word out that treatment for mental illness is available and to make it easier for people to find and receive the treatment they need. If the Board has no objections he plans to put forth a supportive resolution at the next Mayor and Council meeting. Dr. Gasalberti added his support noting with the stigma attached to mental illness people do not seek help and this is also seen with professional agencies such as police and fire departments because once they are labeled it effects their job. Ms. Snow asked who would be responsible for promoting the program in Alpine. Mayor Tomasko advised after the resolution is adopted, the next step will be to appoint an ambassador to disseminate information and basically spread the word that treatment is available as well as training for people interested in helping others. They will also mention the campaign in the newsletter. He noted 20 out of the 70 towns in Bergen County have joined the initiative so far including Cresskill and Demarest. Mayor Tomasko invited the Board to share any other thoughts with him on the topic after they have had time to review the materials provided. Mr. Galdi echoed that the program is a good move.

## **COMMUNICATIONS:**

Dr. Pappas has resigned from the Board. Mayor Tomasko noted Ms. Snow will finish his term as a full member. Mr. Inguaggiato, Sr. was moved up to first Alternate. He welcomes suggestions for the Alternate II position.

The Child Health Conference contract with Hillsdale was executed by the Board of Health secretary as required in January.

Remind that the Bergen County Health Department contract is a two year contract expiring at the end of this year. The County did send an addendum lowering the cost of administration of the Bloodborne Pathogen Training program as most of their courses are now offered online.
