BUSINESS/COMMUNICATIONS: COVID19 Pandemic: Alpine cases 3 in September & October, 9 In November (48 to date). Dr. Laifer questioned status of vaccine distribution when available. Mayor Tomasko advised per earlier Governor's call, priorities are being established by the State: health care workers, congregant care facilities, first responders and more information will be publicly available on their website shortly.

Thanks to resident Gina Toddings for spearheading Alpine's Stigma Free. She led a Community Walk fundraiser on November 1st for the American Foundation for Suicide Prevention. The Board of Health contributed funds for team T-shirts and they raised over \$1,000. Alpine Stigma-Free signs have been posted on Closter Dock Road.
