**AN ORDINANCE AMENDING ARTICLE XXIV OF THE SANITARY CODE OF THE BOROUGH OF ALPINE ENTITLED "SEPTIC TANKS, CESSPOOLS"**

**WHEREAS**, after review of Article XXIV with the Board's Authorized Agent and the Alpine Plumbing Subcode Official, the Alpine Board of Health has determined a practical need to update certain sections of Article XXIV of the Sanitary Code of the Borough of Alpine, New Jersey as follows:

1. The Title of this Section shall be changed from "Septic Tanks, Cesspools" to "Individual Subsurface Sewage Disposal Systems"
2. Under Section 2407 add to the end of the last sentence, "and as subsequently amended."
3. Under Section 2408

The first and second paragraphs are deleted and replaced with the following: "A copy of said printed "Standards" is available from the NJS DEP Division of Water Quality website and a printed copy has been placed on file in the office of the Secretary of the Board of Health for the use and examination of the public and with the Authorized Agent as defined therein and designated by the Board of Health as the official charged with administration and enforcement of this code as herein provided."

**INSTALLATION PERMIT.** Revise the next to the last sentence to read: "A Plumbing Permit for installation and inspection of the laterals and, for system designs containing electrical components an Electrical Permit for installation and inspection of any electrical components, must be obtained from the Building Department at the same time as the Septic Installation Permit."

4. Under section 2410 C. 5. Revise
  - a. to read: "The connection from the house to the septic tank shall conform to the appropriate provisions of the *N.J.A.C. § 5:23-3.15 Plumbing Subcode*
  - d. to read "All connections from the septic tank to the distribution box will conform to the appropriate provisions of the *N.J.A.C. 79:A Standards for Individual Subsurface Disposal Systems.*

This Ordinance shall take effect on final passage according to law.

All ordinances inconsistent herewith in whole or in part, are repealed.

In compliance with N.J.A.C. 7:9A-3.1, within 10 days of adoption, a copy of this ordinance shall be forwarded to the NJ Department of Environmental Protection, Division of Water Quality, Bureau of Nonpoint Pollution Control; PO Box 420, 401 E State Street 3<sup>rd</sup> Floor, Trenton, NJ 08625-0420.
