Introduction Board of Health Ordinance AMENDING ARTICLE XIX "Keeping of Live Poultry or Other Fowl", ARTICLE XX "Keeping of Cattle and Horses," ARTICLE XXIV Section 2408 "Septic Tanks, Cesspools" of the Alpine Sanitary Code and Chapter 109-3 "BOARD OF HEALTH FEES" as included in the Alpine Borough Code."

Secretary Wehmann explained updates were recommended by Health Officer Galdi following inquiries from realtors regarding harboring of hoofed animals and poultry. A review was made of ordinances in other nearby towns and reviewed by Borough officials including the Zoning Officer, Borough Engineer and Tax Assessor as appropriate. Additional updates to the Alpine Sanitary Code are proposed to clarify permit and bond procedures for septic systems to reflect updated procedures. Amendments to the fees are to provide fees for applications relative to XIX and XX and increase test hole fees to reflect actual costs. A brief discussion followed.
