Building Department Councilman Halbreich reported 73 scheduled inspections, 7 zoning review applications and the balance of the report is on file.

Department of Public Works Councilman Shadek read the report of the DPW: Plowing operations during storms, equipment repair and cleanup including overhaul of leaf vacs, Christmas trees chipped, leaf compost facility maintained, responded to all day time fires, attended to affordable housing units repairs, maintenance and tenant concerns, addressed residents concerns. The 2012 Recycling Tonnage Grant received in the amount of \$14,056.57 (included storm debris from Hurricane Sandy).

BOARD OF EDUCATION LIAISON'S REPORT Councilman Shadek reported in December it was noted the necessary funds were raised for school improvements. In January they signed a contract with a builder/contractor. A vacancy on the Board occurred with the resignation of Walter Roura. Katie Martinelli will be taking his place. Councilman Shadek questioned including communications in the newsletter regarding School Field Upgrade Phase II Project to highlight the grant component and to reassure residents that there would be no field lighting, only two stanchions to illuminate sidewalk from DPW parking lot to school for overflow parking.

BOROUGH ATTORNEY'S REPORT Attorney Huntington commented on two agenda items:

• Permission to lease/install cellular miniaturized repeater-type antennas on this building. There was only one bidder. Extent of construction is minimal. Annual rent is \$9,000. If the Borough did not proceed with this award process in the manner utilized, an application would have been received to place the device on private property, an unprecedented event the Borough does not wish to start.

Mayor & Council

- Renewal of curbside recycling contract. The prior supplier was Buldo Carting, present this evening along with his counsel, who by all accounts did a fine job. They are obligated to accept the low conforming bidder which is a company called Bella Cleaning & Carting, LLC at a considerable difference in price. He reviewed the entire contents of the bids in detail with Acting Borough Clerk Beckmann and the defects allegedly contained therein per letter from counsel for Buldo Carting. Correspondence was shared with Bella and their comments invited as well so in so far as possible have a fair exchange of views and better advise the Borough. Having reviewed the objections of Buldo we did not find them to be something that mandated a rejection of the Bella bid or which should cause us to throw out all the bids. The objections were essentially two fold:
- 1) bid documents called for proof that the successful bidder had two compactor trucks or other satisfactory equipment with which to do the collecting process and in their bid documents (and we're obligated to deal strictly with the bid documents) Bella appears to have several vehicles but not two exactly of the type we're told. But as our bid spec noted "or other satisfactory equipment" and it does not appear based on the information before us that we are in position to decide exactly how many trucks or of which type to be had and it wasn't bid that way; it was just proof that there were enough satisfactory vehicles to be able to do it.
- 2) the performance bond had a cap on it saying that from the surety company they would not be responsible for claims in excess of \$300,000 or thereabouts which if the performance bond was supposed to be a million that would be a fatal flaw. In this case the performance bond was supposed to be in the amount of the annual contract and therefore we don't regard a cap several times the face value of the annual contract as being a deficient performance bond.

Mayor Tomasko wished to add that we do value our relationship with Buldo Carting who remains the primary refuse collector in the Borough and he would hate to see anything undercut that. We also appreciate the job that Buldo has done for us in regard to curbside recycling. Attorney Huntington noted in the area of public bidding you may be confronted with a situation where you would like to do other than what would appear to be mandated but unless there is a fatal flaw, and he does not see these as fatal flaws, the Borough is required to take the low bidder.

BOROUGH ENGINEER'S REPORT Borough Engineer Vander Veer had distributed his report.

- Item # 2 Bond release for Tamcrest Estates, LLC is listed on the agenda
- Closter Dock Road Drainage Improvements. His office has received no additional information from the County for many many months on the status of this project. They do want to perform the work on their jurisdiction so we don't know where we stand.
- 2015 Road Improvement Program / Riverside Cooperative They will proceed with the estimate of quantities for the three roads recommended to comply with the anticipated budget: Autumn Terrace, Warren Lane and Overlook Road. He recommends that if the bid prices come in comparable to last year's there may be the ability to also include one of those smaller roads such as Monument Lane or Oxford Way so you may wish to include these in preparation of the Bond Ordinance on the off chance they can be included in the program.

WHEREAS, it is the desire of the Mayor and Council of the Borough of Alpine to participate in a Mutual Aid Plan and Rapid Deployment Force in accordance with the Plan as submitted by the Bergen County Police Chiefs Association
