BOROUGH ENGINEER'S REPORT Mr. Vander Veer advised on the following:
Church Street (State Aide) Project Pre-Construction meeting was held and work is scheduled to begin the second week of July taking 30 days to complete.

Riverside Cooperative Mill \& Pave (Forest Street) Project. Pre-Construction meeting scheduled for July 2 and should begin about two weeks after that following the Church Street project.

Micro-surfacing Project They are waiting for the master contract to be awarded by the Riverside Cooperative.

Councilwoman Frankel asked why it will take 30 days to do a street when they're usually done in 2-3 days. Mr. Vander Veer explained milling and paving is generally 1-2 days each but there is prep work that has to be done including reconstruction of some drainage facilities and the entire asphalt side walk prior to milling and paving. Roads should not be left milled for more than 72 hours. They will be working with the Police Department regarding traffic. The upper section between Closter Dock Road to just past the Borough Hall entrances may need to be closed for about a half a day for the paving. Notices will be put out once the date is known.
