#### **PUBLIC COMMENTS**

Gary W. Whyte, 289 Old Tote Road, Mountainside, NJ requested consideration of a proclamation or resolution to help raise awareness about Fibrodysplasia Ossificans Progressiva (F.O.P.) a rare genetic condition. He became involved back in 2002 when a friend's child was diagnosed and, locally, a girl from Fort Lee is severely affected by this illness. His family raises money for research at the University of Pennsylvania. A drug to potentially treat the disease is now in clinical trials. With this awareness initiative they hope to obtain resolutions or proclamations from all 565 NJ municipalities to be archived with the NJ Historical Society. They have obtained from 426 towns. Mayor Tomasko explained the Borough receives many such requests, thanked Mr. Whyte for bringing this to their attention personally and asked how Council wished to proceed. Councilman Frankel and Councilman Cacouris asked that the Mayor and Council be copied on Mr. Whyte's info for consideration at the next meeting.

4. Resolution #145:6'2015: Resolution Authorizing The Filing Of A Declaratory Judgment Action In The Superior Court Of New Jersey, Law Division And A Motion Seeking Temporary Immunity From Third Party Lawsuits While Pursuing The Declaratory Judgment Action And Taking All Ancillary Actions Associated Therewith To Accomplish That Objective

**WHEREAS**, in 1975 the Supreme Court of New Jersey in <u>South Burlington County N.A.A.C.P. v. Township of Mount Laurel</u>, 67 N.J. 151 (1975), ruled that the developing municipalities in the State of New Jersey exercising their zoning power, in general, had a constitutional obligation to provide a realistic opportunity for the construction of their fair share of the region's low and moderate income housing needs; and

WHEREAS, in 1983, the Supreme Court refined that constitutional obligation in <u>South Burlington County N.A.A.C.P. v. Township of Mount Laurel</u>, 92 N.J. 158 (1983), to apply to those municipalities having any portion of their boundaries within the growth area as shown on the State Development Guide Plan; and

**WHEREAS**, in 1985, the New Jersey Legislature adopted, and the Governor signed the Fair Housing Act ("FHA") which transformed the judicial doctrine which became known as the "Mount Laurel obligation" into a statutory one and provided an alternative administrative process in which municipalities could elect to participate in order to establish a Housing Element & Fair Share Plan ("HE&FSP") that would satisfy its constitutional obligation by creating an administrative agency known as the Council on Affordable Housing ("COAH") to develop regulations to define the obligation and implement it; and

**WHEREAS**, COAH proceeded to adopt regulations for the first round obligations applicable from 1987 to 1993 and second round obligations that created a cumulative obligation from 1987 to 1999; and

**WHEREAS**, prior to the expiration of the second round regulations, COAH embarked upon a process to develop third round regulations utilizing a different methodology for the calculation of a municipality's affordable housing obligation that became known as the growth share methodology; and

**WHEREAS**, the Borough of Alpine ("Borough") was awarded a Judgment of Repose in 2000 for its Second Round Housing Element and Fair Share Plan from the Superior Court at New Jersey Law Division, addressing its cumulative second round affordable housing obligation; and

**WHEREAS**, COAH adopted the first iteration of growth share regulations in 2004 which were invalidated by the Appellate Division in 2007; and

**WHEREAS**, COAH adopted a second and third iteration of the third round regulations in an attempt to accommodate the Appellate Division's decision in 2008; and

**WHEREAS**, the Borough filed its December 16, 2008 Third Round Housing Element & Fair Share Plan with COAH and petitioned for Substantive Certification on December 26, 2008, in accordance with the third iteration of the third round regulations; and

**WHEREAS**, the Borough adopted an amended Third Round Housing Element & Fair Share Plan on May 25, 2010 and re-petitioned COAH for Substantive Certification on June 1, 2010; and

**WHEREAS**, the third iteration of the third round regulations were invalidated by the Appellate Division in 2010, which determined, among other things, that the growth share methodology was invalid *These minutes have been approved by the Mayor & Council.* 

and that COAH should adopt regulations utilizing methodologies similar to the ones utilized in the first and second rounds, i.e. 1987-1999; and

**WHEREAS**, on September 26, 2013, the Supreme Court of New Jersey affirmed the Appellate Division's invalidation of the third iteration of the third round regulations, sustained their determination that the growth share methodology was invalid, and directed COAH to adopt new regulations based upon the methodology utilized in the first and second rounds; and

**WHEREAS**, COAH proceeded to propose such regulations in accordance with the schedule established by the Supreme Court; and

**WHEREAS**, on October 20, 2014, COAH deadlocked on the adoption of the revised regulations; and

**WHEREAS,** Fair Share Housing Center ("FSHC"), an interested party and housing advocacy group filed a motion with the Supreme Court to enforce litigant's rights in light of COAH's deadlock and subsequent inaction; and

**WHEREAS**, on March 10, 2015 the Supreme Court issued its decision on FSHC's motion to enforce litigant's rights and in doing so established a procedure for municipalities to utilize to transition their applications pending before COAH to the judicial system in order to achieve similar protections that the municipality would have received had the COAH process proceeded; and

**WHEREAS**, the procedure established by the Supreme Court requires that by July 8, 2015 a participating municipality (of which the Borough is one), bring a Declaratory Judgment action in the Law Division of the Superior Court before the designated <u>Mount Laurel</u> judge on notice and an opportunity to be heard to a variety of entities, to declare the municipality's HE&FSP as being constitutionally compliant; and

**WHEREAS**, the Supreme Court gave the Borough the right to seek temporary immunity from third party lawsuits while it pursues its Declaratory Judgment action; and

WHEREAS, on April 9, 2015 the Appellate Division issue its decision in the case entitled In re Failure of the Council on Affordable Housing to Adopt Trust Fund Commitment Regulations, Docket No. A-5257-11T4 and Docket No. A-0122-13T3 wherein they divested COAH of jurisdiction to effect a forfeiture of Affordable Housing Trust Funds not spent or committed to be spent within four years of their receipt and transferred jurisdiction over any such actions to the 15 Mount Laurel designated judges who would also be hearing the Declaratory Judgment actions abovementioned; and

**WHEREAS**, there remains pending before COAH unapproved Spending Plans potentially preventing municipalities from utilizing their Affordable Housing Trust Funds in an appropriate manner; and

**WHEREAS**, in light of the transition of jurisdiction to effect a forfeiture of Affordable Housing Trust Funds to the Court, it is appropriate to seek approval for any unapproved Spending Plan by the Court as part of the Declaratory Judgment action, if circumstances warrant; and

**WHEREAS**, the Borough desires to authorize the initiation of a Declaratory Judgment action in order for the Borough to proceed to validate a HE&FSP to be prepared by the Borough Planner; to seek temporary immunity while it pursues the Declaratory Judgment action; and to take all ancillary actions associated therewith to accomplish that objective.

**NOW, THEREFORE, BE IT RESOLVED** by the governing body of the Borough of Alpine, County of Bergen, State of New Jersey as follows:

- 1. Robert A. Kasuba, Esq. / Bisgaier Hoff LLC is hereby authorized and directed to initiate a Declaratory Judgment action in the Superior Court of New Jersey, Law Division, to seek a declaration that the Borough's HE&FSP, to be prepared by the Borough Planner, is constitutionally compliant and satisfies the Borough's affordable housing obligation for the period ending in Year 2025, or such other time period as may be determined by subsequent proceedings and to seek approval of its Spending Plan, if appropriate.
- 2. Said Declaratory Judgment action shall be filed no later than July 8, 2015, the deadline set forth in the Supreme Court decision above referenced, for the filing of such an action.
- 3. Simultaneous with the filing of the Declaratory Judgment action, Robert A. Kasuba, Esq. / Bisgaier Hoff LLC is hereby authorized and directed to seek and obtain temporary immunity from any third party lawsuits associated with the Borough's affordable housing obligation, for a minimum period of five months or such other time as the Court may direct, in

order to allow the Borough and its Planner to complete a revised HE&FSP to reflect and accommodate the Borough's affordable housing obligation through Year 2025, or such other time period as may be determined by subsequent proceedings.

- 4. The governing body requests the Planning Board to authorize the Borough Planner to prepare a revised HE&FSP as part of the Master Plan of the Borough which, among other things, will establish the affordable housing obligation of the Borough through year 2025, or such other time period as may be determined by subsequent proceedings, and further establish a mechanism to satisfy that obligation.
- 5. The Borough requests that the governing body representatives participate in the review of the HE&FSP prior to its public hearing and disposition by the Planning Board inasmuch as the Borough will be required to endorse the same as part of its proceedings to obtain the protections to be afforded to it through the Declaratory Judgment action abovementioned.
- Robert A. Kasuba, Esq. / Bisgaier Hoff LLC and Burgis Associates, Inc. and all other appropriate Borough professionals, employees, elected, and appointed officials are hereby authorized and directed to take any and all steps necessary to effectuate the purposes of this Resolution.

**WHEREAS**, it appears from the public records that the lane may have been dedicated as a street but not accepted, maintained or opened by the Municipality as a conforming street; and

**WHEREAS**, the Borough of Alpine believes that it is in the best interest of the Municipality to permit K.O. Realty Alpine, L.L.C. to undertake the repairs described on the Rider hereto.



End of Consent Agenda Resolutions Resolution removed from Consent Agenda:

#### Soil Moving Permit Application Cho Block 39.01 Lot 9.12, 28 Graham Street

**Discussion:** Mayor Tomasko opened the floor to Councilman Cacouris regarding the proposed resolution. Councilman Cacouris reviewed: a property owner on Graham Street has applied for a soil moving permit to move over 10,000 cubic yards of soil which the Planning Board approved with a number of conditions attached. Council is asked to endorse that Board's decision that this permit would not be detrimental. He distributed a photo and graphic to help conceptualize the large volume. He finds it hard to sign off that this would not cause environmental or other problems.

Mayor Tomasko thanked Councilman Cacouris for his comments. He reminded Councilwoman Gerstein and himself sit on the Planning Board and assured the body deliberated for some time on the matter before moving it forward. He asked Borough Engineer Vander Veer to comment. Mr. Vander Veer noted he did not have the file with him this evening but explained the figure represents total volume of soil moved and not necessarily the amount being imported or exported; it may be mostly cut and fill amounts on site. In addition, most of the soil moving activity related to installation of the septic systems already installed as it is the Planning Board's policy not to hear an application for soil moving until after the septic systems are substantially installed. Fill for the septic system may be offset by excavation of soil for the basement and the specific details are on file.

## (6.) Resolution #150:6'2015 Table Endorsement of Planning Bd. Approval Soil Moving Permit Application Cho Block 39.01 Lot 9.12, 28 Graham Street

**OFFERED BY:** Councilman Frankel **SECONDED BY:** Councilman Cacouris at a regular meeting of the Mayor and Council of the Borough of Alpine held on Wednesday, June 24, 2015 to table matter to obtain additional information.

**Discussion:** Mayor Tomasko felt the Planning Board had spent considerable time on the matter and recommended they move the matter forward advising Planning Board of their concerns for future applications. Councilman Shadek questioned practical implications of a delay. Mr. Vander Veer stated the owner could only proceed at their own risk. Councilwoman Frankel, having served on the Planning Board, voiced confidence in their recommendations. Councilman Cacouris echoed this respect but noted it is Council's approval being sought and he would like more information; this is a record volume of soil movement. Mr. Vander Veer could not give a precise number of times but recalled such amounts have been approved before. Councilman Frankel cited due diligence oversight responsibility where he does not feel he has sufficient information. Mayor Tomasko noted this is the same situation as last month: being asked to go back and obtain information they could have sought out prior to the meeting. He does not think that's fair. The person who picks up on a question needs to get all the information so they can provide a full picture to the governing body rather than making people wait another 30 days for action.
