# Resolution 072:03'2025 Introduction of Ordinance #838: To Exceed the Municipal Budget Appropriation Limits & Establish a Cap Bank (N.J.S.A. 40A:4-45.14) CY 2025

INTRODUCED BY: Councilwoman Gerstein SECONDED BY: Councilman Kupferschmid

**WHEREAS**, the Local Government Cap Law, N.J.S. 40A:4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.5% or the cost of living adjustment, whichever is less, unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

**WHEREAS**, the cost of living adjustment for calendar year 2025 budgets is calculated at 2.5% pursuant to N.J.S.A. 40A:4-45.2 and amounts to \$140,454; and,

**WHEREAS**, N.J.S.A. 40A:4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

**WHEREAS**, the Borough Council of the Borough of Alpine in the County of Bergen finds it's advisable and necessary to increase its CY 2025 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

**WHEREAS**, the Borough Council hereby determines that an additional 1.0% increase in the budget of said year, amounting to \$56,181 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

**WHEREAS**, the Borough Council hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

**NOW, THEREFORE BE IT ORDAINED**, by the Borough Council of the Borough of Alpine, in the County of Bergen, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the 2025 budget year, the final appropriations of the Borough of Alpine shall, in accordance with this ordinance and N.J.S.A. 40A:4-45.14, be increased by 3.5%, amounting to \$196,635, and that the 2025 municipal budget for the Borough of Alpine be approved and adopted in accordance with this ordinance; and,

**BE IT FURTHER ORDAINED**, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

**BE IT FURTHER ORDAINED**, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

**BE IT FURTHER ORDAINED**, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

#### TAX ASSESSOR'S REPORT on file

MAYOR'S REPORT There was a Safety Committee meeting last week. We are in good stead with our insurance carrier. The Mayor thanked Stephanie Wehmann for her work. Mayor Tomasko visited the Commissioner of the Department of Community Affairs and the Division of Local Government Services in Trenton last week and discussed issues such as affordable housing and the Open Public Records Act, as well as the need for more classes to be given for positions such as Chief Financial Officer and in more convenient locations.

#### **REPORTS OF THE STANDING COMMITTEES**

**Administration Department** As of the end of February, the Borough has responded to 111 OPRA requests this year. **Building Department** 36 Scheduled Inspections, 2 tree permits, 2 Zoning Review applications, and 1 miscellaneous application.

**Department of Public Works** There was an after-hours call for a downed tree. Spring cleanup has commenced, including chipping all of the roadside brush, cutting back growth along roadsides and at intersections, removing a number of dead trees, and picking up litter. A consultant was escorted through the Borough-owned buildings for the completion of the RTK Survey.

**Police Department** There were 342 calls for service; 47 motor vehicle/Borough ordinance summonses, 2 radar summonses on Route 9W, 1 on Closter Dock Road; and 6 motor vehicle accidents. There were 31 burglar alarms, 0 burglaries, and 12 false alarms. The report is on file.
