BOROUGH OF ALPINE ORDINANCE NO. 846

AN ORDINANCE TO AMEND SECTION 209-9 SCHEDULE I: NO PARKING

BE IT ORDAINED by the Mayor and Council of the Borough of Alpine that Section 209-9. Schedule I: No Parking shall be amended as follows:

§ 209-9. Schedule I: No Parking.

In accordance with the provisions of § 209-3C, no person shall park a vehicle at any time on any of the following described streets:

Anderson Avenue [Added 4-26- 2023 by Ord. No. 821]	East	Along the easterly curbline between the north end and Hickory Lane
Berkery Place [Added 9-23- 2009 by Ord. No. 706]	Both	Between signs as designated and posted
Church Street	Both	Between the southerly curbline of Closter Dock Road and the northerly side line of Haring Lane, with such line extended to the west side of Church Street
		Between the northerly curbline of Hillside Avenue and the point of intersection of the northerly curbline of Miles Street with Church Street
	East	Between the intersection of the southerly curbline of Schoolhouse Lane and the northerly curbline of Haring Lane
Closter Dock Road	Both	Between the westerly curbline of U.S. Route 9W and a point 150 feet to the west on both sides of the road
	South	Between Church Street and a point 250 feet west of U.S. Route 9W
Haring Lane	Both	Between the easterly curbline of Church Street and the point of intersection of the easterly line of the Fire Department driveway with Haring Lane
Hillside Avenue	Both	250 feet from the intersection of Hillside Avenue and Church Street along both sides of Hillside Avenue
Hilltop Lane	Both	Starting at Hillside Avenue running south until you reach the opening to the main parking lot at the southern end of the roadway
Old Dock Road	<u>Both</u> West	Between the northerly curbline of Closter Dock Road and the point of intersection of Old Dock Road and Ridge Street The entirety of Old Dock Road
Ridge Street	West	Between the point of intersection of Ridge Street and Old Dock Road and the southerly curbline of Forest Street

If any section, subsection, part, clause or phrase of this Ordinance shall be declared invalid by judgment of any court of competent jurisdiction, such section, subsection, part, clause or phrase shall be deemed to be severable from the remainder of this Ordinance.

This Ordinance shall take effect immediately upon final passage and publication as required by law.
