MAYOR'S REPORT The Mayor reported on the following:

- Resident e-mail received about several incidents of a drone flying about 60 feet over her property raising concerns with security and privacy and to ask what can be done about this. The Borough Clerk and Police Chief are researching. Challenges include ensuring local codes do not conflict with FAA rules and ability to identify the source for enforcement. Meanwhile the Mayor recommended this resident communicate with her neighbors in an attempt to locate and resolve with the source. This is an evolving technology. Without objection Attorney Huntington will also look into this.
- Tax bills went out after receiving the County tax rate. CFI included a note indicating the
 overall rate increase was due to County taxes at 4.9%, the County quadrupling the
 open space tax rate, and a school tax rate of 2.9%. The municipal increase was 0.6%.
 Last year we had a slight decrease so hopefully next year will be better.

WHEREAS, Velocity Ride-Columbia's Ride to End Cancer is a bicycling fundraiser organized to raise funds for Columbia University Medical Center's Herbert Irving Comprehensive Cancer Center with riders committing to ride 10, 25, 45 or 62.5 miles to reach fundraising minimums depending on the distance registered for; and

WHEREAS, the Director of Velocity Ride has requested authorization from the towns through which riders will traverse; and

WHEREAS, approximately 500 participants are anticipated to ride through Alpine between 11:00 AM and 3:30 PM for the final 10 Mile phase of the event with the original proposed route entering Alpine from Closter on Anderson Avenue, continuing along Closter Dock Road. and Route 9W South, and exiting the Borough toward Tenafly; and

WHEREAS, upon further review, the Police Chief has requested that Closter Dock Road be bypassed for traffic and safety considerations and the organization has agreed to revise the route through Alpine as follows: to continue along Anderson Avenue to County Road, through the Boroughs of Demarest and Cresskill, turning left onto Hillside Avenue at County Road, re-entering the Borough of Alpine and turning right onto Route 9W South toward the Borough of Tenafly; and

WHEREAS, the organization has agreed to notify and coordinate with the surrounding towns affected by the route change and, in accordance with the Police Chief's further recommendation, the organization has agreed, at its sole expense, to have an Alpine Police Officer posted at the intersection of Hillside Avenue and Route 9W for traffic control purposes; and

WHEREAS, provided all stipulations are met, Police Chief Belcolle has no objections and will be actively coordinating with the organization regarding any additional police assistance that may be deemed necessary; and

WHEREAS, authorization of the bike event is subject to receipt, review and approval of the organization's Certificate of Liability Insurance and a Facilities Use Hold Harmless Agreement by the Borough's Risk Manager.

NOW, THEREFORE BE IT RESOLVED, that the Mayor and Council of the Borough of Alpine authorize the Velocity Ride Event to be held on Saturday, October 7, 2017, conditional upon all requirements being met prior to the event.
