BOROUGH OF ALPINE BERGEN COUNTY, NEW JERSEY ORDINANCE NO. 788

A CAPITAL ORDINANCE APPROPRIATING THE SUM OF \$186,500 FOR VARIOUS IMPROVEMENTS TO BE UNDERTAKEN BY THE BOROUGH OF ALPINE AND TO APPROPRIATE \$166,400 FROM A NEW JERSEY DEPARTMENT OF TRANSPORTATION GRANT AND \$20,100 FROM GENERAL CAPITAL SURPLUS.

<u>BE IT ORDAINED</u>, by the Borough Council of the Borough of Alpine in the County of Bergen, New Jersey (not less than two-thirds of all members thereof affirmatively concurring) as follows:

<u>SECTION 1.</u> The improvements described in Section 2 of this Ordinance are hereby respectively authorized as general improvements to be made by the Borough of Alpine, New Jersey, for the said improvements or purposes stated in Section 2, there is hereby appropriated the sum of money therein stated as the appropriation made for said improvements or purposes, said sum being inclusive of all appropriations herefore made thereof and amounting in the aggregate to \$186,500 which is now available in the amount of \$166,400 from a New Jersey Department of Transportation Grant and \$20,100 from General Capital Surplus.

<u>SECTION 2.</u> The Borough of Alpine, in the County of Bergen, State of New Jersey, is hereby authorized to provide for the following:

Acquisition of a Swim Pool Cover

\$186,500

<u>SECTION 3.</u> It is hereby determined and stated:

(a) That said purposes are not a current expense. That the same are improvements which the municipality may lawfully make and that no part of the cost of said improvements has been or shall be specifically assessed on properties specifically benefited.

(b) It is not necessary to finance said appropriations by the issuance of obligations by the Borough of Alpine pursuant to the Local Bond Law of the State of New Jersey, for the reason that monies sufficient to cover the appropriations thereof shall be available in the amount of \$166,400 from a New Jersey Department of Transportation Grant and \$20,100 from General Capital Surplus.

<u>SECTION 4.</u> The Capital Budget of the Borough of Alpine is hereby amended to conform with the provisions of this Ordinance to the extent of any inconsistency herewith. The resolution in the form promulgated by the Local Finance Board showing all detail of the amended Capital Budget and capital program and is available for public inspection.

SECTION 5. The sum of \$186,500 is hereby appropriated for the aforementioned purposes.

<u>SECTION 6</u> It is hereby determined and stated that no supplemental debt statement is required to be made and signed in connection with said appropriations, since the gross debt of the municipality, as defined under the Local Bond Law, is not increased by this Ordinance and no obligations in the matter of notes or bonds are authorized by this Ordinance.

<u>SECTION 7</u> This Ordinance shall take effect after publication thereof and final passage as required by law.
