WHEREAS, N.J.S.A. 40A:5-4 requires the governing body of every local unit to have made an annual audit of its books, accounts and financial transactions, and

WHEREAS, the Annual Report of Audit for the year **2022** has been filed by a Registered Municipal Accountant with the Municipal Clerk pursuant to N.J.S.A. 40A:5-6, and a copy has been received by each member of the governing body, and

WHEREAS, R.S. 52:27BB-34 authorizes the Local Finance Board of the State of New Jersey to prescribe reports pertaining to the local fiscal affairs, and

WHEREAS, the Local Finance Board has promulgated <u>N.J.A.C.</u> 5:30-6.5, a regulation requiring that the governing body of each municipality shall by resolution certify to the Local Finance Board of the State of New Jersey that all members of the governing body have reviewed, as a minimum, the sections of the annual audit entitled: General Comments and Recommendations; and

WHEREAS, the members of the governing body have personally reviewed as a minimum the Annual Report of Audit, and specifically the sections of the Annual Audit entitled: 'General Comments – Recommendations' as evidenced by the group affidavit form of the governing body attached hereto, and

WHEREAS, such resolution of certification shall be adopted by the Governing Body no later than forty-five days after the receipt of the annual audit, pursuant to <u>N.J.A.C.</u> 5:30-6.5; and

WHEREAS, all members of the governing body have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board, and

WHEREAS, failure to comply with the regulations of the Local Finance Board of the State of New Jersey may subject the members of the local governing body to the penalty provisions of <u>R.S.</u> 52:27BB-52 - to wit: <u>R.S.</u> 52:27BB-52 - "A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provision of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office."

NOW, THEREFORE BE IT RESOLVED, That the Mayor and Council of the Borough of Alpine, hereby states that it has complied with <u>N.J.A.C.</u> 5:30-6.5 and does hereby submit a certified copy of this resolution and the required affidavit to said Board to show evidence of said compliance.

Mayor Tomasko recognized Alpine's CFO Marilyn Hayward. Alpine can be proud that the 2022 audit found no deficiencies that merited recommendations for corrective action.

MAYOR'S REPORT

- The Mayor recognized DPW Superintendent Greg Zaremba and invited Borough Engineer Perry Frenzel to discuss what had initially been a substantial funding request for drainage improvements. A storm drain on Cassandra Drive was found to be nonfunctioning and was replaced in-house by the DPW. In addition DPW made substantial improvements to the Pike Street detention pond and spillway and repaired a pipe collapse on that street. Repairs represented a substantial cost savings. Councilman Kupferschmid added his thanks to Mr. Zaremba for his solutions and amazing, quick work. The Mayor and Council asked Mr. Zaremba to relay the Mayor and Council's appreciation to his department.
- Alpine Swim Club is winding up another successful season. Thanks to all the committee volunteers along with DPW Superintendent Zaremba and Councilman Bosworth for their efforts that allowed residents to benefit from this spectacular facility.
- Four Bergen County towns (Englewood, Old Tappan, Franklin Lakes and Mahwah) have been in the news regarding resident pushback after towns settled their affordable housing obligation. We are doing our best to avoid that and negotiations continue to provide the least impactful solution.

- Shared Services. A neighboring mayor organized a meeting of several mayors inviting representatives from DCA to discuss shared services. The Mayor shared DCA's handout noting alpine already shares listed most of their suggested services with neighboring communities and/or the County.
- Receipt of a letter of resignation from Brian Frugis, Construction Code Official, Zoning Officer and Building Inspector thanking the Borough. Mr. Frugis has served for 15 years. The Mayor expressed appreciation for the department's organization and efforts by the Technical Assistant to secure replacements for the positions which should provide for a smooth transition.
