ORDINANCE NO. 765 AN ORDINANCE ESTABLISHING CHAPTER 35 ARTICLE IV § 35-36 CREATING AN HISTORIC PRESERVATION COMMISSION FOR THE BOROUGH OF ALPINE

BE IT ORDAINED by the Mayor and Council of the Borough of Alpine that:

- A. There is hereby created in and for the Borough of Alpine a commission as provided for in <u>N.J.S.A.</u> 40:55D-107 to be known as the "Historic Preservation Commission of the Borough of Alpine".
- B. The powers of the Historic Preservation Commission shall be performed by the Planning Board pursuant to <u>N.J.S.A.</u> 40:55D-25.
 - i. At least one (1) member of the Planning Board shall meet the requirement of a Class A Member and one (1) shall meet the requirements of a Class B Member and the remaining members can be Class C Member.
 - a. Class A: a person who is knowledgeable in building design and construction or architectural history.
 - b. Class B: a person who is knowledgeable or with a demonstrated interest in local history.
 - c. Class C: any citizen of the Borough who holds no other municipal office, position or employment other than membership on Planning Board or the Zoning Board of Adjustment.
- C. The Commission shall elect from its membership a Chairman and a Vice Chairman.
- D. The Commission shall create rules and procedures for the transaction of its business, subject to the following regulations:
 - (1) The Commission's members, including the Chairman or, in his absence, the Vice Chairman, but not less than a majority of the full authorized membership, may grant or deny a certificate of appropriateness.
 - (2) The Commission shall appoint a Secretary, who need not be a member of the Commission. The Secretary shall keep minutes and records of all meetings and proceedings, including voting records, attendance, resolutions, findings, determinations and decisions. All such material shall be public records.
 - (3) All meetings shall comply with the Open Public Meetings Act (N.J.S.A. 10:4-6 et seq.).
- E. The Commission members shall serve without compensation but shall be reimbursed for expenses incurred in the performance of official business.
- F. Within the limits of funds appropriated for the performance of its work, grants and gifts, the Commission may obtain the services of qualified persons to direct, advise and assist the Commission and may obtain the equipment, supplies and other material necessary to its effective operation.
- G. The Commission is empowered to seek advisory opinions and technical assistance from all municipal employees on any matter within the Commission's jurisdiction. The Commission shall obtain its legal counsel from the Borough Attorney or such other attorney so designated by the Mayor, with the advice and consent of the Council, at a rate of compensation to be determined and approved by the governing body. Expenditure pursuant to this subsection shall not exceed, exclusive of gifts or grants, the amount appropriated by the governing body for the Commission's use.
- H. Powers and Duties. The Commission shall:

- (1) Prepare and adopt a Landmarks Designation List and Landmarks Map.
- (2) Make recommendations to the Planning Board on the Historic Preservation Plan Element of the Master Plan and on the implications for preservation of historic sites of any Master Plan elements.
- (3) Advise the Planning Board on the inclusion of historic sites in the recommended capital improvement program.
- (4) Advise the Planning Board and Board of Adjustment on applications for development pursuant to <u>N.J.S.A.</u> 40:55D-110.
- (5) Provide written reports, pursuant to <u>N.J.S.A.</u> 40:55D-111, on the application of the Zoning Ordinance provisions concerning historic preservation.
- (6) Hear and decide advisory applications for certificates of appropriateness.
- (7) Amend, from time to time, as circumstances warrant, the Landmarks Designation List and Landmarks Map-
- (8) Collect and disseminate material on the importance of historic preservation and techniques for achieving the same.
- (9) Advise all municipal agencies regarding goals and techniques of historic preservation.
- (10) Adopt and promulgate such regulations and procedures not inconsistent with this chapter as are necessary and proper for the effective and efficient performance of the duties herein assigned.

Except as provided for herein, all other provisions of the Ordinance shall remain in full force and effect.

If any section, subsection, part, clause or phrase of this Ordinance shall be declared invalid by judgment of any court of competent jurisdiction, such section, subsection, part, clause or phrase shall be deemed to be severable from the remainder of this Ordinance.

This Ordinance shall take effect immediately upon final passage and publication as required by law. INTRODUCED: October 26, 2016 ADOPTED: December 14, 2016

BE IT RESOLVED, by the Planning Brand of the Borough of Alpine that the following Procedure' History, Findings of Fact and Conclusions of Law are hereby adopted in reference to this matter.

PROCEDURAL HISTORY

An application was made before the Alpine Planning Board by Alpine Elite Development, LTD ("Applicaul") for a soil movement permit with requested waivers for more than 30% of pool coping above permitted height above original grade with portions in excess of five feet above original grade. The property is located on Stone Tower Drive. The lot is identified on the Borough Tax Maps as Block 22, Lot 12 ("Property"). The application was made pursuant to the Municipal Land Use Law and the ordinances of the Borough of Alpine.

The application was deemed to be substantially complete by the Borough Engineer and was referred to the Planning Board for its agonda for September 27, 2016.

Proof of compliance with the notice requirements of the Borough soil movement ordinance was provided to the satisfaction of the Board Secretary.

The application was heard by the Planning Board on September 27, 2016. The Application was presented by Matthew Capizzi, Esq.. At the meeting Douglas Doubittle, P.R. testified with regard to plans prepared by McNally Engineering, L.L.C.

FINDINGS OF FACT

The Board considered the following materials:

A plan entitled "Site Plan, Alpine Elite Development L.L.C. (sic), Block 22-Lot 12, 23 Sinne Tower Drive, Borough of Alpine, Bergen County New Jersey", prepared by McNally Engineering, L.L.C. dated April 8, 2016 and last revised on August 30, 2016.

Application and Cheek list for Soil Movement unlated.

Application for Zoning Review dated August 19, 2016 filed by Alpine Flite Development LTD.

Document emitted "Storm Drainage Report for Alpine Elite Development LLC (sic) Lot 12, Block 22" prepared by McNally Engineering, L.L.C. dated May 14, 2016.

Decornent eraitled "Retaining Wall Stability Calculations for Alpine Elite Development, L.C. (sic), Lot 12 – Block 22" prepared by McNally Bagineering, L.L.C. dated May 14, 2016.

Reports prepared by Gary Vander Veer, P.E. dated August 25, 2016, September 7, 2016, and September 9, 2016.

Architectural Plans consisting of seven sheets (T-1, A 1.3, A/2, A/3, A-4, A-6 and A-7) prepared by Zampolin & Associates, duied August 2, 2016 revised to September 1, 2016

- 2. The application was for the provement of 3,264 cubic yards of soil (868 cubic yards to be imported) with requested wrivers from the provision of the ordinance with regard to the placement of pool orging more than five feet above original grade and more than 30% of the prod coping more than these feet above original grade.
- 3. Doughts Doublittle, P.E. a licensed professional engineer. The witness described the lot as inregular in his capacity as a prefessional engineer. The witness described the lot as inregular in shape, on a enryc in the road and containing a 1970's house with pool all of which will be removed. Using Sheet 4 of the plans on file dated April 8, 2016 and revised to August 30, 2016, the witness described the soil movement proposal, the nature of the development or site, and the need for the requested waivers. These related to the pool are to allow a better height relationship between the pool and the first floor of the dwelting. There is no impact on neighboring properties. The pool could be lowered to avoid the writers but there would then have to be a series of steps down from the house to the pool. Since the additional fill will be retained by a wall a substantial distance from any property line the witness felt there was no impact on adjoining property. The property in general stopes from the front to the rear. The witness also offered Exhibit A-Uneing a Goegle earth photo showing the present property.
- 4. After discussion with the Applicant's counsel, it was agreed that this was to be a seven, not eight between home and certain revisions would be made to the architectural plans as noted below. The Board concludes that the requested waivers are appropriate and will have Sittle or no impact on any adjacent properties and represent a better alternative for development.

CONCLUSIONS.

Upon hearing the testimony produced on behalf of the Applicant and studying the exhibits, and with the Applicant's consent to the proposed conditions, the Planning Board manimously voted to approve the soil movement permit application with the waivers subject to Mayor and Council approval, and ease subject to the following:

- A. Compliance with the first of Required Revisiona/Supplements set forth in the engineering reports of Gary Vander Veer, P.E. dated August 25, 2016, September 7, 2016 and September 9, 2016, copies of which is annexed hereto and incorporated by reference.
- B. Submission of acceptable proof of liability insurance coverage held by or for the benefit of the Borough as an additional named insured in mittimum amount of one million dollars, combined single limit and submission of a performance guarantee and revegetation guaranty in the amounts determined by the Borough Engineer.
- C. This Board approval incorporates the plan described in Findings of Fact 1 and bast revised on August 30, 2016.

Any deviations from the elevations or contours indicated thereas shall be referred by the Applicant to the Borough Engineer, who may approve such modification or refer the Applicant back to the Planning Board for review.

- D. The architect, to the autisfaction of the Board Engineer, shall demonstrate the area of the attic which is seven feet or more in heigh). If this area does not meet ordinance standards for a half story, this approval shall be void and the Applicant will need to apply to the Zoning Board of Adjustment. The architect shall also revise the plans to confirm that this is a seven bedroom home and not eight bedrooms as shown in the Code Analysis on sheet T-1 of the plans.
- E. The Applicant will remove the force which encroaches onto adjoining property.
- F. In the ovent that the Borough Engineer detamnines that any deviations from the approved plan are major, the Engineer shull notify the Applicant that the approval is void and the Applicant must return to the Planning Board for additional review.
- G. Soil is not to be moved from or to the site during (hose hours that children are going (a, or coming from school, before the hour of 8 a.m. or on Sundays or holidays.
- 11. The Applicant will be required to publish a brief notice of the decision in the official newspaper of the Borough in the time and manner provided by hav not provide proof of publication to the Board Secretary.
- The Applicant is required to obtain all other government approvals including the Revironmental Controlssion and County Soil Conservation District.
- J. The Applicant shall be required to apply for any required thee Removal Permit.

The Board has resolved that a copy of this Resolution shall be provided to the Applicant, the Construction Code Official of the Borough of Alpine, the Secretary of the Planning Board, and the Borough Clerk.
