## **MAYOR'S REPORT** The Mayor reported on the following:

- Announce with sadness passing of former longtime Health Officer, Bill Galdi. He was highly esteemed and there was a massive outpouring at the services. We shall miss Bill but he won't be forgotten and we were fortunate to be able to know and work with him for all those years.
- Wide concerns with impacts of the new federal tax bill on NJ real estate values. It is
  not known how this will play out but it is being reported this could depress values
  although it is hoped Alpine would fare better, having the lowest tax rates of all 77
  Bergen County municipalities, but no one is immune. There is also concern
  regarding the impact if Governor-elect Murphy carries through with the Millionaire's
  tax as far as our state remaining competitive and attracting and keeping
  businesses. We will keep attentive to these matters.
- In January Alpine becomes host for the Interboro Radio, a two year term inherited from Northvale. We all benefit from this program that keeps costs down.
- The Mayor and Council Reorganization meeting is January 3, 2018 at 4:00 PM.

# **REPORTS OF THE STANDING COMMITTEES**

Administration Department No report.

**Building Department** Councilman Halbreich read the report's main statistics:

71 scheduled inspections, 5 tree permits, 1 soil moving application, and 5 zoning review applications. Balance of report on file.

Department of Public Works Councilman Frankel advised the report is on file.

Mayor Tomasko wished to note the following:

- DPW did a fine job with leaf pickup despite 3 snowstorms. Remaining leaves must be bagged or residents should make private arrangements with their landscaper.
- He attended a meeting of the Riverside Cooperative today. The Coop will be press the County to increase the hourly reimbursement rates to municipalities for

plowing (including sanding/salting) of County roads. The rates have not been raised in years.

• LED lights were installed in the Borough Hall and parking lot to reduce utility costs.

**Fire Department** Councilwoman had advised she could not attend. On her behalf Mayor Tomasko noted the following:

- As usual the Fire Department did a great job hosting Santa's visit to the Firehouse last Saturday from 10AM – 12 Noon which traditionally marks the start of Alpine's holiday season.
- Thanks to Councilman and Fireman Halbreich for the beautiful display of photographs in the Borough Hall lobby and hopefully, the residents will better appreciate the wonderful work our volunteer fire department does for us. When the alarm goes off thirty families get disturbed, even if the middle of the night.

**Police Department** Councilwoman Frankel reported 30 motor vehicle summonses issued. There were 6 motor vehicle accidents with 2 injuries. November mandated training included Active Shooter and Firearms Qualifications. The rest of the report is on file.

# **BOROUGH ENGINEER'S REPORT** Mr. Vander Veer distributed his report and highlighted:

- Work complete on the Alpine School field. The sidewalk, lighting, sprinkler system, field work and sod are in place. Charles Hoffmann had a big hand in ensuring all work was well coordinated.
- 2017 Road Improvement Work. Site inspection today verifies all work completed. They should receive the final invoice and change order for next month to reflect an 8-9% reduction from the contract cost.
- Municipal Stormwater Permit regulations. He has reviewed in detail. He previously provided a letter to the governing body and will provide more detail at next month's meeting regarding specific requirements and timetable for implementation, particularly in regard to mandatory training.

Mayor Tomasko provided Mr. Vander Veer with the memo reflecting the proposed timetable for next year's Riverside Cooperative road improvement projects.
