WHEREAS, N.J.S.A. 40A:5-4 requires the governing body of every local unit to have made an annual audit of its books, accounts and financial transactions, and

WHEREAS, the Annual Report of Audit for the year 2016 has been filed by a Registered Municipal Accountant with the Municipal Clerk pursuant to N.J.S.A. 40A:5-6, and a copy has been received by each member of the governing body, and

WHEREAS, R.S. 52:27BB-34 authorizes the Local Finance Board of the State of New Jersey to prescribe reports pertaining to the local fiscal affairs, and

WHEREAS, the Local Finance Board has promulgated <u>N.J.A.C.</u> 5:30-6.5, a regulation requiring that the governing body of each municipality shall by resolution certify to the Local Finance Board of the State of New Jersey that all members of the governing body have reviewed, as a minimum, the sections of the annual audit entitled: General Comments and Recommendations; and

WHEREAS, the members of the governing body have personally reviewed as a minimum the Annual Report of Audit, and specifically the sections of the Annual Audit entitled: 'General Comments - Recommendations' as evidenced by the group affidavit form of the governing body attached hereto, and

WHEREAS, such resolution of certification shall be adopted by the Governing Body no later than forty-five days after the receipt of the annual audit, pursuant to N.J.A.C. 5:30-6.5; and

WHEREAS, all members of the governing body have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board, and

WHEREAS, failure to comply with the regulations of the Local Finance Board of the State of New Jersey may subject the members of the local governing body to the penalty provisions of <u>R.S.</u> 52:27BB-52 - to wit:

R.S. 52:27BB-52 - "A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provision of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office."

NOW, **THEREFORE BE IT RESOLVED**, That the Mayor and Council of the Borough of Alpine, hereby states that it has complied with <u>N.J.A.C.</u> 5:30-6.5 and does hereby submit a certified copy of this resolution and the required affidavit to said Board to show evidence of said compliance.

WHEREAS, the Borough of Alpine Police Department has used the Borough of Haworth Police Firearms Training Facility located at 341 Lake Shore Drive for state qualifying shooting and practice for several years; and

WHEREAS, the Boroughs of Haworth and Alpine desire to formalize this arrangement by entering into an Interlocal Shared Services Agreement with the Borough of Haworth for this purpose; and

WHEREAS, the agreement will run retroactively from April 25 2017 through December 31, 2017 at a cost of \$300.00 per officer for 12 sworn officers which cost will not exceed \$3,600.00. Funds are available in AC# 7-01-25-240-035; and

WHEREAS, use of the range will be coordinated by the Police Chiefs of the respective municipalities and their departmental range officers and insurance for the use of the Haworth range by Borough of Alpine is provided through the Bergen County Municipal Joint Insurance Fund.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council, Borough of Alpine, County of Bergen to authorize the Mayor and the Borough Clerk to enter into an interlocal agreement shared service agreement with the Borough of Haworth for use of the Haworth Police Firearms Training Facility located at 341 Lake Shore Drive for state qualifying shooting and practice including the Hold Harmless Agreement and Disclaimer Statement.

COMMUNCIATIONS: WRITTEN AND ORAL

Mayor Tomasko distributed a news article on the Northern Valley Greenway.

Mayor read a letter from the relatively new plumbing inspector, Thomas Zirconie:

"Since taking this position over a year ago, it was immediately brought to my attention that the Borough of Alpine has a town ordinance in place requiring that the waste lines which run from the house to the septic system be only constructed of extra heavy cast iron with poured lead joints. I am quite sure Alpine is the only town in North America with this requirement. This ordinance supersedes the state plumbing code. It is, and has been, a financial hardship for both homeowners and plumbing contractors alike. The system of using extra heavy cast iron with poured lead joints is archaic. It is almost the equivalent of writing on stone tablets. At this time, I respectfully request that you strongly consider revising the Borough ordinance to mirror the state code and bring the plumbing requirement into the 21st century."

Mayor Tomasko noted this is one point of view and there are other points of view to be heard from such as our engineer. He's already heard from the construction code official who provided justification and noted our recently retired health officer was a big proponent of this provision in our sanitary code. The letter was just received on June 24th but will be provided to Council.

Councilman Cacouris noted this year's audit report stated: "we did not identify any deficiencies in internal controls that we consider to be a material weakness." Spot testing of various controls "disclosed no instances of noncompliance or other matters that are required to be reported under the government auditing standards." This is as good as it gets and he thanked the finance staff for their hard work.
