MAYOR'S REPORT The Mayor reported on the following:

- The Municipal Budget represents an increase for the average Alpine home assessed at \$2,724,000 of only \$27 which represents a remarkable job again this year. The tax rate goes from 16.2¢ to 16.3¢ per \$100 of assessed value. The actual tax levy went up by about \$15,000 and overall spending increased by about \$100,000. The Mayor emphasized the municipal portion is only one component of the annual property tax bill. The overall tax rate is heavily dependent on what the County and School do in regard to taxes. The municipal budget in no way compromises the high quality of service we continue to provide residents.
- Our Borough is privileged to have a wonderful Safety Committee led by Safety Officer Ralph Wehmann. Stephanie Wehmann runs the Safety Committee meetings. Alpine scored the highest points of any municipality in the North Bergen JIF and was awarded the Gold Award plaque and \$2,000 at this week's Annual Safety Breakfast. He is proud and grateful to all employees not one of whom missed work for a job-related incident last year.
- Document Shredding Day is scheduled for April 30th in the Borough Hall parking lot between 9 AM 1 PM.
- **Appointment:** A vacancy has occurred on the Recreation Commission and he wishes to appoint Galina Glazebnik with the Council's approval.
