The Mayor and Council, Borough of Alpine, convened for this Regular Meeting on Monday, November 21, 2016 at 7:30 P.M. in the Alpine Borough Hall. The Public Announcement was read and the Pledae of Allegiance recited.

In accordance with the provisions of the New Jersey Open Public Meetings Law, the notice of this Regular Meeting held Monday, November 21, 2016 has met the requirements of the law by being published in The Record as part of the Annual Notice, posted on the bulletin board of the lobby in the Borough Hall and a copy filed in the office of the Borough Clerk. COUNTY HISTORICAL PRESENTATION Mayor Tomasko welcomed Bergen County Clerk John Hogan. Prior to George Washington's time it was the County Clerk, appointed by the king, who maintained records such as land records. He is the 36th Clerk dating back to those times and noted the County Clerk for 8 months during George Washington's time was also named John Hogan. As all 70 towns were established each had to file their documents with the County Clerk such as original incorporation papers and results of the first elections. They issue exempt firefighter certificates (for firemen who have served seven years or more) and have these original documents. He has worked to preserve these documents scanning and storing originals in acid free sleeves. In addition to preservation his goal is to share some of these original documents that are unique to each municipality in the form of a collage presentation choosing the best preserved and most memorable documents. The display includes maps filed in 1875 and 1878, original incorporation papers and an exempt firefighter certificate. Mr. Hogan explained one collage poster is presented to the town and a second copy will be displayed in the Land Records Management Division which will also include a historical research area.

County Clerk Hogan advised the County Clerk's office is available to set up a three-day 10AM – 2PM satellite office in the municipal building offering services for passports, business trade names, notary public, photo cards for senior citizens, veterans and exempt firemen, voter registration, vote by mail applications and about half the services that they offer in their Hackensack office. They also help match veterans with appropriate resources and services. They cannot process land records locally at this time. The County Clerk's office generates \$71 million per year for the County of Bergen and another \$71 million for the State of New Jersey. They run on a budget of \$4.7 million with 55 employees. They will come speak to any civic group such as senior citizens and youth groups. Mayor Tomasko thanked Mr. Hogan and advised they will advertise in the next newsletter to ascertain interest.
