<u>BOROUGH ENGINEER'S REPORT</u> Mr. Vander Veer distributed his report. The only action item was the Change Order resolution. With that approval the 2016 DOT Municipal Aide project can be closed out.

MS4 Stormwater Permit NJ State's municipal storm water permitting process began back in 2004. This is the third time the State has modified procedures and this is by far the most expansive to date. He previously provided comments to the Mayor and Council on the preliminary and draft versions. The new regulations were adopted substantially unchanged from the drafts and become effective January 1, 2018. Provisions will require significantly more recordkeeping, primarily on the part of the DPW Superintendent, as well as conversion of documents and maps to electronic format for submission to DEP and posting on the Borough's website. Some of the work is one time only providing for annual updates thereafter. This is an unfunded state mandate. He will review the adopted

regulation in more depth and keep the governing body informed of what needs to be done to remain compliant.

Mayor Tomasko emphasized the 140 pages of additional regulations require more mapping, inspections, documentation and education. He noted the irony that municipalities have to face this significant increase in workload in the waning months of an administration that portrayed itself as reducing regulation. It is disappointing that the State provides no funding and made no significant changes to the draft versions despite all of the input from municipalities and organizations across the state including the NJ League of Municipalities, Bergen County League of Municipalities, Society of Municipal Engineers. Mr. Vander Veer noted he did not have time to review the over 200 pages of questions and answers on this issue.
