**New Jersey State League of Municipalities 1st Vice President** Council President Gerstein asked to read the following media release from NJLM:

Mayor Tomasko of Alpine is the new 1st Vice President of the New Jersey State League of Municipalities. Mayor Tomasko was elected at the League of Municipalities' Annual Business Meeting in atlantic City.

As 1st Vice President of the NJLM Mayor Tomasko will help lead the Association of New Jersey's 654 municipal governments. He will represent the interests and needs of New Jersey's local elected officials to county, state and federal governments.

Mayor Paul Tomasko has been on the NJLM Executive Board since 2014 and he was named to the Gold Level of the League's Mayors Hall of Fame in 2018.

Mayor Tomasko has lived in the Borough of Alpine for 46 years and has served Alpine for more than 30 years starting as a member of the Alpine Environmental Commission in 1985 to 1986. He has been a member of the Borough's Planning Board since 1997 and began elected office as a Councilman 1991 through 1996. In 1999 he began his first term as Mayor of Alpine.

He has been on the Palisades Interstate Parkway Commission since 2021. Formerly President of the Bergen County League of Municipalities (2010-2021), Mayor Tomasko is a member of the Executive Boards of the Bergen Municipal Joint Insurance Fund, the Environmental Joint Insurance Fund, the Residual Claim Fund, the Municipal Excess Liability Joint Insurance Fund and the Palisades Park Conservancy.

Mayor Tomasko thanked Council President Gerstein noting the title gives him a bigger soapbox to represent the needs of the constituency. Attorney Kool expressed appreciation for all his service noting the Mayor has been an advocate for municipalities throughout the state on important issues such as affordable housing and OPRA and many others. Applause followed.

**WHEREAS**, the Uniformed Shared Services and Consolidation Act, <u>N.J.S.A.</u> 40A:65-1 <u>et seq.</u>, allows any municipality or county to enter into a contract with any other municipality or county for the joint provision of any services within their joint jurisdiction; and

WHEREAS, the Borough of Paramus and the Borough of Alpine each have respective obligations to provide and administer affordable housing programs for the purpose of providing their required fair share of the regional present and prospective need for families at low- and moderate-income levels; and

**WHEREAS**, the New Jersey Fair Housing Act, <u>N.J.S.A.</u> 52:27D-301 <u>et seq</u>. (the "Fair Housing Act") recognizes and encourages municipalities to cooperate with and work together to achieve the goal of the Fair Housing Act; and

WHEREAS, the Borough of Paramus and the Borough of Alpine are each located in Bergen County and within New Jersey Affordable Housing Region 1 as designated and defined by COAH; and

WHEREAS, the Borough of Alpine, recognizing the expertise of the Borough of Paramus in its administration of its affordable housing obligations, previously entered to a shared services agreement with the Borough of Paramus (the "Shared Services Agreement") pursuant to which the Borough of Paramus provides administrative services for the Borough of Alpine's affordable housing programs, which services will include serving as the administrative agent for the Borough of Alpine, assuming responsibility for compliance with the rules and regulations of the Council on Affordable Housing ("COAH") and the management and oversight of affordable housing programs and the construction, management and oversight of the sale and renting of affordable housing units located in the Borough of Alpine; and

**WHEREAS**, it is now in the best interests of the Borough of Alpine to enter into an agreement with the Borough of Paramus amending the fee schedule terms of the Interlocal Services Agreement, effective January 1, 2024.

**NOW, THEREFORE, BE IT RESOLVED,** that the Governing Body of the Borough of Alpine hereby authorizes the Mayor and Borough Clerk to execute and deliver the Interlocal Services Agreement set forth in this resolution

**WHEREAS**, the Uniform Shared-Services Act (USSA) found at N.J.S.A. 40A:65-1 was passed in an effort to encourage and ease the sharing of services; and

WHEREAS, there exists a need for the Borough of Alpine and its Health Department to provide state mandated health services of a technical and professional nature and

WHEREAS, the Borough of Alpine desires to contract for the furnishing of certain of these health services by the BCDHS to the Borough of Alpine, pursuant to N.J.S.A. 26:3A2-1 et seq.; as provided for in the contract and summarized as follows:

Bloodborne Pathogens Program Coordination pursuant to N.J.S.A. 40A:60-1 et seq. and in compliance with P.E.O.S.H.A. as follows: Exposure Control Plan Development; Policies and Procedures; Training Programs; and Record/Report Generation and Retention and billing support documentation at a cost not to exceed \$25 per each trained employee.

WHEREAS, for purposes of cost stabilization the term of this Agreement will be for two (2) years beginning January 1, 2024 and expiring December 31, 2025;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Alpine as follows:

- 1. That the Borough Clerk and/or the Mayor are hereby authorized and directed to execute an agreement with the Bergen County Department of Health Services to perform the public health services of a professional nature which services and costs are outlined above
- 2. This contract is awarded without competitive bidding in accordance with N.J.S.A. 40A:11-5(2); and **BE IT FURTHER RESOLVED** that this agreement shall be dependent upon the future appropriation of funds in the 2024 and 2025 fiscal year budget for the purposes of this contract and the Chief Financial Officer providing a certification, to be affixed to this resolution, as to the availability of funds for this contract upon that appropriation.

## **GOVERNING BODY ACKNOWLEDGMENT OF BEST PRACTICES INVENTORY**

The Best Practices Inventory was certified and submitted on November 1, 2023, ahead of the November 3<sup>rd</sup> deadline. The Mayor met with Borough Officials to review BPI questions and responses prior to submission. This year's inventory was comprised of 67 questions including unscored survey questions designed to obtain information from the municipality on its practices. At the time of submission there was an inventory score of 37 which should result in no penalty or withholding of Property Tax Relief (CMPTRA) and Energy Tax Receipts (ETR), or other applicable state aid, based on the rubric provided in Local Finance Notice 2023-17. The entire report with questions and answers is available for review. Mayor Tomasko added the State's BPI mandate, initiated years ago, adds another level of red tape. While touted as a means to collect and monitor municipal practices it is noteworthy that no questions on the impact of OPRA or affordable housing appear on the list. In his humble opinion the state missed a significant opportunity to thoroughly examine statewide municipal concerns and feedback about those matters and make necessary and long overdue changes to both. The State has a costly and inefficient approach to affordable housing in particular and where the intent of OPRA was transparency it has become overrun with requests and overlaid with numerous often contradictory court decisions. It has become incredibly burdensome to municipal staff and many municipalities throughout the state have had to hire personnel just for that purpose. It impacts all departments including police and particularly the Borough Clerk. He is committed to getting action from the state on these two issues. Councilman Kupferschmid asked who makes those decisions at the Mayor Tomasko advised DCA and he has made his comments known to the State level. Commissioner. He hopes next year the BPI will be more relevant to the needs of municipalities.
