WHEREAS, it is the policy of Borough of Alpine to treat the public, employees, prospective employees, appointees, volunteers and contractors in a manner consistent with all applicable civil rights laws and regulations including, but not limited to the Federal Civil Rights Act of 1964 as subsequently amended, the New Jersey Law against Discrimination, the Americans with Disabilities Act and the Conscientious Employee Protection Act, and

**WHEREAS**, the governing body of the Borough of Alpine has determined that certain procedures need to be established to accomplish this policy.

**NOW**, **THEREFORE BE IT ADOPTED** by the Mayor and Council of the Borough of Alpine that:

Section 1: No official, employee, appointee or volunteer of the Borough of Alpine by whatever title known, or any entity that is in any way a part of the Borough of Alpine shall engage, either directly or indirectly in any act including the failure to act that constitutes discrimination, harassment or a violation of any person's constitutional rights while such official, employee, appointee volunteer, or entity is engaged in or acting on behalf of the Borough of Alpine's business or using the facilities or property of the Borough of Alpine.

Section 2: The prohibitions and requirements of this resolution shall extend to any person or entity, including but not limited to any volunteer organization or inter-local organization, whether structured as a governmental entity or a private entity, that receives authorization or support in any way from the Borough of Alpine to provide services that otherwise could be performed by the Borough of Alpine.

Section 3: Discrimination, harassment and civil rights shall be defined for purposes of this resolution using the latest definitions contained in the applicable Federal and State laws concerning discrimination, harassment and civil rights.

Section 4: The Borough Council shall establish written procedures for any person to report alleged discrimination, harassment and violations of civil rights prohibited by this resolution. Such procedures shall include alternate ways to report a complaint so that the person making the complaint need not communicate with the alleged violator in the event the alleged violator would be the normal contact for such complaints.

Section 5: No person shall retaliate against any person who reports any alleged discrimination, harassment or violation of civil rights, provided however, that any person who reports alleged violations in bad faith shall be subject to appropriate discipline.

Section 6: The Borough Council shall establish written procedures that require all officials, employees, appointees and volunteers of the Borough of Alpine, as well as all other entities subject to this resolution to periodically complete training concerning their duties, responsibilities and rights pursuant to this resolution.

Section 7: The Borough Council shall establish a system to monitor compliance and shall report at least annually to the governing body the results of the monitoring.

**Section 8:** At least annually, the Borough Clerk shall cause a summary of this resolution and the procedures established pursuant to this resolution to be communicated within the Borough of Alpine. This communication shall include a statement from the governing body expressing its unequivocal commitment to enforce this resolution. This summary shall also be posted on the Borough of Alpine's web site, if applicable.

Section 9: This resolution shall take effect immediately.

Section 10: A copy of this resolution shall be published in the official newspaper of the Borough of Alpine in order for the public to be made aware of this policy and the Borough of Alpine's commitment to the implementation and enforcement of this policy.

WHEREAS, on August 14, 2015, the Borough of Alpine ("Borough" or "Alpine") filed a Complaint in the matter captioned In the Matter of the Application of the Borough of Alpine, Docket No. BER-L-6286-15 ("DJ Litigation"), seeking a declaration from the New Jersey Superior Court that its Housing Element and Fair Share Plan ("HEFSP") and Zoning Ordinances are constitutionally compliant; and

WHEREAS, Fair Share Housing Center ("FSHC") has been designated as an interested party in the DJ Litigation pursuant to <u>In re N.J.A.C. 5:96 and 5:97</u>, 221 N.J. 1, 30 (2015)("<u>Mount Laurel IV</u>"); and

**WHEREAS**, the Borough and FSHC have engaged in settlement negotiations and have come to an agreement resolving all of the differences between them with regard to the DJ Litigation including the satisfaction of the Borough's affordable housing obligation; and

WHEREAS, the terms and conditions of said agreement are set forth in a certain Settlement Agreement dated October 18, 2023; and

WHEREAS, the Alpine desires to resolve the issues between the Borough and FSHC with regard to the DJ Litigation as set forth in the Settlement Agreement.

**NOW, THEREFORE, BE IT RESOLVED** by the Borough Council of the Borough of Alpine, County of Bergen, State of New Jersey as follows:

1. All the terms and conditions of a certain Settlement Agreement by and between Fair Share Housing Center and the Borough dated October 18, 2023, be and the same are hereby approved, ratified and confirmed by the Borough subject to (i) a satisfactory reconciliation of the Borough's RDP of 32 with its compliance commitment of 34 credits; and (ii) a satisfactory clarification of any carry-forward obligation for affordable housing units and/or credits referenced in Paragraph 10 of said Settlement Agreement to satisfy the Borough's RDP of 32 and to satisfy the Borough's 12 family unit credit requirement, which may result from less than four accessory apartment units being created or in progress by July 1, 2025.

2. The Borough Mayor and the Borough Clerk are hereby authorized to execute said Settlement Agreement subsequent to the execution by FSHC and, together with other appropriate officers and employees of the Borough, are hereby authorized to take all steps necessary to effectuate the purposes of this Resolution.

#### AUTHORIZING THE EXECUTION OF A SETTLEMENT AGREEMENT

WHEREAS, the Borough of Alpine ("Borough" or "Alpine") is involved in litigation in the New Jersey Superior Court, captioned Sylco Investments #4, LLC et al v. Borough of Alpine, Docket No. BER-L-0293-20 ("Litigation"); and

WHEREAS, the parties have entered into discussions in an effort to resolve the Litigation by adopting a revised zoning ordinance to permit the development of a 40 unit townhouse development on the property commonly known as Block 55, Lots 26-30 on the Official Tax Map of the Borough of Alpine ("Property"), which will create a realistic opportunity for the construction of 8 affordable housing units; and

WHEREAS, the parties have arrived at form of settlement agreement dated October 25, 2023 containing all the terms and conditions thereof; and

**WHEREAS**, the Borough desires to resolve the issues by entering into the settlement agreement and approving its terms and conditions.

**NOW, THEREFORE, BE IT RESOLVED** by the Borough Council of the Borough of Alpine, County of Bergen, State of New Jersey as follows:

1. All the terms and conditions of a certain Settlement Agreement by and between the Borough and the developer entities consisting of F.E. Alpine, Inc.; Sylco Investments #4, LLC; Sylco Investments 854, LLC; 850 Closter Dock Road, LLC; 842 Closter Dock Road, LLC and Sylco Investments #5, LLC dated October 25 2023 be and the same are hereby approved, ratified, and confirmed by the Borough, subject to a revision of Exhibit A to the Settlement Agreement to reflect the signage standards recommended by the Borough's Planner, Joseph Burgis, PP, AICP, specifically, regarding the identification signs located on Closter Dock Road, having a maximum sign area of 24 square feet; a maximum height of signage letters of 10 inches; and a maximum height of signage of 42 inches, with the maximum wall height on which the signage shall be placed, inclusive of any ornamental features on the wall structure, being 6 feet.

The Borough Mayor and the Borough Clerk are hereby authorized to and directed to execute said Settlement Agreement with the revisions to Exhibit A noted above subsequent to the execution thereof by the developer entities and, together with other appropriate officers and employees of the Borough, are hereby authorized and directed to take any and all steps necessary to effectuate the purposes of this Resolution.

3. The Borough hereby authorizes and approves any non-substantive modifications to the Settlement Agreement as may be recommended and approved by the Borough Mayor, Borough Attorney, Borough Special Counsel, and Borough Planner in this Litigation prior to execution.

4. This Resolution shall take effect immediately.

#### BOROUGH OF ALPINE ORDINANCE NO. 822

# AN ORDINANCE BY THE BOROUGH OF ALPINE IN THE COUNTY OF BERGEN, STATE OF NEW JERSEY AMENDING SECTION 220-18-C(2) OF THE ALPINE MUNICIPAL CODE ENTITLED "CERTIFICATE OF CONTINUED OCCUPANCY"

WHEREAS, the Alpine Building Department has recommended changes in the titled code section to the Mayor and Council, and

WHEREAS, the Borough Council after consultation with the department believes that amending Chapter 220-18 of the Borough Code is in the best interests of the Borough to protect the health, safety and welfare of the public.

**NOW THEREFORE, BE IT ORDAINED**, by the Mayor and Council of the Borough of Alpine, in the County of Bergen, State of New Jersey, as follows:

1. The Alpine Municipal Code Section 220-18 C(2) entitled "Certificate of Continued Occupancy" is hereby deleted in its entirety and replaced with the following:

2. New Alpine Municipal Code Section 220-18 C(2) entitled "Certificate of Continued Occupancy, Certificate of Non-Compliance"

- (2) Certificate of Continued Occupancy Resale requirements upon the transfer of ownership.
  - (a) Certificate of Continued Occupancy Resale shall be required upon any transfer of ownership to an existing premises which is accompanied by a change in the occupancy of such premises.
  - (b) The Certificate of Continued Occupancy Resale shall be evidence that a general inspection of the visible parts of the principal building, property or other structures on the property have been made and that there are no apparent visible violations of the Borough of Alpine ordinances, New Jersey Uniform Construction Code, the New Jersey Uniform Fire Code or other applicable, County, State or Federal Codes, Statues or Regulations have been determined to have occurred and no unsafe conditions have been found.
  - (c) An application for a Certificate of Continued Occupancy Resale required by this section shall be made in writing on forms provided by the Alpine Building Department. The application shall be submitted at least 20 business days prior to the proposed change of occupancy. Upon receiving the required completed application and fees the Code Official/Building Inspector shall inspect the property within 10 business days. In the event that the Code Official/Building Inspector declines to issue a certificate of occupancy resale, his/her reasons for doing so shall be stated in writing and a copy be given to the applicant. The applicant must request a reinspection once all violations have been corrected to the satisfaction of the Code Official/Building Inspector.
  - (d) Application fee for a Certificate Continued of Occupancy Resale upon the transfer or change of ownership shall be based upon the amount of time remaining before the change of occupancy is expected as follows:
    - The fee for a certificate of continued occupancy resale upon the change of occupancy for a one family dwelling or commercial or industrial building are as follows:
      10 or more days prior \$400.00 residential \$600.00 commercial or industrial
      4 to 10 days prior \$600.00 residential \$800.00 commercial or industrial
      4 days prior \$800.00 residential \$1,000.00 commercial or industrial
    - 2. The fee for a Re-Inspection is \$90.00 for each reinspection request.

(3) A Certificate of Non-Compliance shall be required for the transfer of ownership in the event that the principal building is to be demolished or when there are outstanding issues that need to be corrected and approval can only be obtaining after closing.

(a) Procedure to obtain a Certificate of Non-Compliance - Request shall be made in writing on forms supplied by the Alpine Building Department. The application must be presented to the Code Official/Inspector. This form must be completed, signed by the Seller(s) and must be notarized. Also, required is a Letter of Understanding Regarding Application for Certificate of Non-Compliance. This form must be completed, signed by both the Seller(s) and Buyer(s) and must be notarized. Executed documents must be submitted to the Alpine Building Department. These documents must be reviewed and approved by both the Borough Attorney and the Borough Engineer. Once approvals are received the Code Official/Inspector will issue a Certificate of Noncompliance for the transfer of ownership ONLY. Occupancy is prohibited until violations are corrected and a Certificate of Occupancy is obtained.

- (b) The fee for a Certificate of Non-Compliance if \$400.00
- (4) Failure to submit a completed application for a Certificate of Occupancy Resale or a Certificate of Non-Compliance upon the change of ownership to an existing premises shall result in the levying of a fine in the amount of \$1,000.00 against the owner of record of the property at the time that the change of occupancy or title occurred. Said owner(s) shall also be subject to a per diem charge of \$100.00 for each and every day that a completed application is not submitted starting from the day of discovery by the Alpine Building Department. This section will be enforced by the Code Official of the Borough of Alpine.

3. Any article, section, paragraph, subsection, clause, or other provision of the Alpine Municipal Code inconsistent with the provisions of this ordinance is hereby repealed to the extent of such inconsistency.

4. If any section, paragraph, subsection, clause, or provision of this ordinance shall be adjudged by a court of competent jurisdiction to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause, or provision so adjudged, and the remainder of this ordinance shall be deemed valid and effective.

5. This ordinance shall take effect upon its passage and publication and filing with the County of Bergen Planning Board, and as otherwise provided for by law.
