**WHEREAS**, Assembly Bill 1094 was signed into law on July 25, 2019 being an act P.L. 2019 Ch. 199 prohibiting employer inquiries about worker's wage and salary experience, effective January 1, 2020; and

**WHEREAS**, the Borough Attorney has reviewed the recommended updates in accordance with the requirements of state law and recommendations of the Personnel Administrator;

**NOW, THEREFORE BE IT RESOLVED** that the Borough's Managerial/Supervisory Procedures Manual is hereby approved, as amended in accordance with the recommendations as follows:

Page 21 Amend Employee Application under Employment History to remove any reference to Starting and Ending Salary.

Page 27 Add section on Salary History

## New per P.L. 2019 c. 199 7/25/2019

## Salary History

This section shall not apply to:

- 1. Application for internal transfer or promotion or prior employment with current employer.
- 2. Any action pursuant to a federal law or regulation that expressly requires disclosure of salary history.

Any inquiry regarding salary history, including, but not limited to, the applicant's prior wages, salaries or benefits

Any requirement that applicant's salary history satisfy minimum or maximum criteria.

Employer shall not retain or consider any salary history that is obtained publicly or from a former employer unless the applicant voluntarily without employer prompting or coercion provides the employer with the information or written authorization to obtain salary history. Refusal to provide salary history shall NOT be considered in employment decisions.

- 1) Only if an applicant **voluntarily**, without employer prompting or coercion provides salary history the employer may consider salary history in determining salary, benefits, and other compensation for the applicant, and may verify the applicant's salary history.
- 2) Only after an offer of employment that includes an explanation of the overall compensation package has been made to the applicant can an employer request that the applicant provide employer with a written authorization to confirm salary history that was voluntarily provided, including but not limited to the applicant's compensation and benefits. If salary history is not volunteered and/or written authorization provided the employer not Employer's action to verify non-salary history information must state that salary history information is not to be disclosed.

**WHEREAS**, the Uniform Shared-Services Act (USSA) found at N.J.S.A. 40A:65-1 was passed in an effort to encourage and ease the sharing of services; and

**WHEREAS**, there exists a need for the Borough of Alpine and its Health Department to provide state mandated health services of a technical and professional nature and

**WHEREAS**, the Borough of Alpine desires to contract for the furnishing of certain of these health services by the BCDHS to the Borough of Alpine, pursuant to N.J.S.A. 26:3A2-1 et seq.; as provided for in the contract and summarized as follows:

Bloodborne Pathogens Program Coordination pursuant to N.J.S.A. 40A:60-1 et seq. and in compliance with P.E.O.S.H.A. as follows: Exposure Control Plan Development; Policies and Procedures; Training Programs; and Record/Report Generation and Retention and billing support documentation at a cost not to exceed \$20 per each trained employee plus \$400.00 for purchase of vaccine as needed under State Contract based on \$67.00 per vaccination plus lab fees if titer-testing indicated.

WHEREAS, for purposes of cost stabilization the term of this Agreement will be for two (2) years beginning January 1, 2020 and expiring December 31, 2021 at which time the agreement shall be automatically renewed for a successive two (2) year term unless terminated for reasons as contained in the agreements;

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of Alpine as follows:

- 1. That the Borough Clerk and/or the Mayor are hereby authorized and directed to execute an agreement with the Bergen County Department of Health Services to perform the public health services of a professional nature which services and costs are outlined above
- 2. This contract is awarded without competitive bidding in accordance with N.J.S.A. 40A:11-5(2); and

**BE IT FURTHER RESOLVED** that the Chief Financial Officer has certified, in accordance with N.J.A.C. 5:30 14.5 that sufficient legally appropriated funds will be available for this purpose subject to appropriation of funds in the 2020 adopted budget.
