BOARD OF EDUCATION LIAISON'S REPORT Councilman Shadek reported communication from Board of Ed President Phil Simotas commending Superintendent/Principal Maureen McCann and team who have done a fantastic job preparing the school to receive students. Mr. Simotas is happy to report Alpine is one of the few districts in the area that will open with a hybrid schedule. More than 80% of the students will be attending class in person when they start after Labor Day. The school has been outfitted with signage, social distancing instructions, sneeze guards on each desk, protocols for teachers and students and the new building custodian has the school looking spectacularly clean with most of the rooms freshly painted and the floors stripped and resealed. Student enrollment is at record levels at 155 including several tuition paying students. Additional Tenafly parents have expressed interest in paying tuition to send their children to the school. They can expect Alpine to receive positive attention for the way they are handling the pandemic crises.
