POLICE COMMENDATION Mayor Tomasko wished to commend the Alpine Police Department and several officers in particular noting this recognition will also be included in the next newsletter:

Arrests of Alpine Burglary Suspects: On July 18 Officer Matt Gough assisted in a joint investigation with both the Bergen County Prosecutors Office and other Bergen County Police Departments on the execution of a search warrant in Elizabeth, NJ. The warrant resulted in the arrest of three suspects on charges of conspiracy to commit burglary, money laundering, receiving stolen property, possession of false government documents and possession of burglary tools. These suspects are very possibly linked to burglaries in Alpine in the past. On August 24, 2023 at 4:30 in the morning Alpine Police Officers Brian Prunk and Christopher Amato responded to a residence in Timberline for a burglary in progress. A search of the area with multiple police departments and other agencies resulted in the arrest of three suspects. All three suspects were processed at Alpine Police Department and transported to a Bergen County jail. Multiple charges were filed against all three suspects specifically attempted burglary, resisting and conspiracy to commit burglary. We commend the fine officers of the Alpine Police Department for their work and their dedication to keeping Alpine Safe around the clock."

Applause followed. Mayor Tomasko observed Chief Kent along with almost the entire department were present to hear this commendation. He also welcomed retired officer Stuart Conboy.

Councilwoman Frankel added: "We'd like to thank you for being the well trained diligent officers we expected you to be. We're proud that you were there when needed. We thank you for your important role in making our town the safe and wonderful place it is to live. Thank you again for all your helpfulness."

Officer Prunk wished to emphasize that this was not just the work of two officers. None of this would have happened without the team effort of the entire department. Sergeant Colussi and Officer Ariano quickly responded back to work to assist. Sergeant Simpson and Officer Dippe came in to secure the prisoners for a lengthy amount of time prior to transport by Officers Bourke and Morzetta. Everyone in the department pitched in and continues to do so as this remains an ongoing investigation.

Councilman Kupferschmid echoed his appreciation for all of the emergency responders whose work does not go unnoticed.

WHEREAS, hunger and food insecurity are a reality for far too many of our neighbors; and WHEREAS, those who are food insecure are without reliable access to an adequate amount of affordable, nutritious food. Food insecurity can affect anyone, whether they are recently unemployed, underemployed, or supporting a large family; and

WHEREAS, food insecurity is a symptom of broader challenges, such as unemployment, disability, retirement or unforeseen financial hardships; and

WHEREAS, those who do not have their basic needs met are further hampered in their path toward self-sufficiency; and

WHEREAS, ongoing economic instability has increased food insecurity amongst individuals and families throughout Bergen County and across the country; and

WHEREAS, food pantries in Bergen County have experienced an approximately 22% increase in need for food assistance compared to last year, and a 40% increase in need from the unprecedented levels seen in 2020 due to the COVID-19 pandemic; and

WHEREAS, there are residents in every municipality in Bergen County who receive SNAP benefits, illustrating that this is an issue impacting residents all across Bergen County; and

WHEREAS, the economic coattails of the pandemic are long, and despite the end of Federal and state emergency declarations, tremendous need still exists within our community; and

WHEREAS, the Bergen County Food Security Task Force was established to support food pantries in Bergen County by increasing the supply of healthy food options, connecting those in need to vital services, and investing in long term infrastructure to build a more resilient pantry network to ensure no one in Bergen County goes hungry; and

WHEREAS, the Bergen County Food Security Task Force has been incorporated into the Department of Human Services as the new Office of Food Security to reaffirm that the county's commitment to fighting hunger continues past the pandemic; and

WHEREAS, the energy, philanthropy, and hands-on efforts of a multitude of volunteers throughout the county make a tremendous impact in combatting hunger in our community, and are vital in meeting the struggles of our neighbors with compassion; and

WHEREAS, the Borough of Alpine is fortunate to host a collection box for the Norwood Food Pantry within our municipality; and

NOW, THEREFORE, BE IT RESOLVED that the Mayor and Council hereby recognizes the month of September 2023 as "Hunger Action Month" in the Borough of Alpine, and encourages all Bergen County residents to support their local food pantries.

BE IT FURTHER RESOLVED that this Mayor and Council is committed to ending hunger in Bergen County and will spread awareness and increase engagement in our community to solve this problem
