- Notice of Freshwater Wetland Application to NJDEP re: Block 31 Lot 4, 59 Robin Lane: Mayor Tomasko reminded the board that they have an opportunity to comment on matters such as this as usual. Engineer Frenzel reported that the application is for the installation of six seepage pits and a drainage system that will result in disturbance to a regulated wetland buffer area The Mayor noted that the operative sentence is that the applicant is for reconstruction and expansion of the existing single-family dwelling. If the board chooses, we can let the DEP know that we are opposed to any disturbance to the wetland areas. Mr. Frenzel stated that there is a standard letter that we have sent to DEP in the past advising them of our concerns. All were in favor. He will draft a letter in response to this notification.

COMMITTEE REPORTS:

<u>Bergen County League of Municipalities</u>: Mayor Tomasko reported that the State League of Municipalities' Executive and Deputy Executive Directors spoke at the most recent meeting, mostly in regard to the Governor's budget address. They took questions and feedback from those in attendance. Mayor Tomasko provided suggestions that should have priority for the league to advocate: 1) Affordable Housing reform, 2) OPRA reform. Unfortunately, the State does not seem particularly moved to reviewing and reforming the existing system which is, in his opinion, the least efficient approach to Affordable Housing.

<u>Board of Health</u>: Report on file. In response to Ms. Parilla's inquiry, the Mayor commented that the State has not been providing numbers for COVID-19 cases, and welcomed those that are interested in following up on Lyme

Disease and COVID statistics to attend the next Board of Health meeting or contact our Board of Health Secretary Stephanie Wehmann for updates. Next meeting is May 7th.

<u>Environmental Commission</u>: Ms. Mattes reported that they are preparing for Arbor Day, which is scheduled for Friday, April 28th this year. Unfortunately, they will not be giving out seedlings because they can only get bare rooted seedlings; no dirt, which need to be planted within five days or they will die, and to pick them up is a two-hour long drive. Instead the Commission will be planting a tree at the Swim Club. Greg Zaremba, DPW Superintendent, recommended an area near where the kiddie pool used to be that is very wet, and suggested a Red Maple to absorb some of the water. They spoke with a few people at a nursery who concurred that a Red Maple would do wonderfully and is fast growing. Ms. Mattes welcomed everyone to join in the planting of the tree on April 28th at 1PM.

Building Department: Report distributed; no comments.

<u>NJ Transit Update</u>: No activity. Ms. McGuire commented that the tunnel must be built. It is a matter of time as everyone knows this is needed, but there are many people that need to be involved and it requires coordination between Engineers, the Federal Government and New Jersey-New York Authorities.

<u>COAH Update</u>: Deferred to Executive Session. Mayor Tomasko commented that Alpine has protection from Builder's Remedy lawsuits which has been extended through mid-May.

Upon a motion by Ms. Gerstein, seconded by Ms. Herries to enter into Executive Session. All were in favor. The Board entered into Executive Session at 7:53 PM and returned to Open Public Session at 8:22 PM.
