1. LOCAL ORDINANCE (CH.68) REQUIRES LICENSES FOR DOGS OR CATS LICENSING AGE (7 MONTHS OR OLDER) OR WITHIN 10 DAYS OF REACHING SAME. NEW DOG/CATS MUST BE LICENSED WITHIN 10 DAYS OF ACQUISITION. ANY DOG/CAT BROUGHT INTO THE BOROUGH FOR MORE THAN 10 DAYS MUST BE LICENSED IN THE BOROUGH (EXCEPT IF LICENSED IN ANOTHER STATE IN WHICH CASE YOU MUST OBTAIN A LICENSE IF THEY LIVE IN THE BOROUGH MORE THAN 90 DAYS).
2. ALL DOG AND CAT LICENSES EXPIRE ON JANUARY 31 OF EACH YEAR AND MUST BE RENEWED DURING THE MONTH OF JANUARY.
3. ALL DOGS AND CATS MUST BE LICENSED - EVEN IF YOUR PET NEVER LEAVES THE HOUSE.
4. CHECK RABIES AND NEUTER STATUS. IF THIS IS A NEW REGISTRATION OR THERE HAVE BEEN ANY CHANGES SINCE THE LAST REGISTRATION, BE SURE TO ENCLOSE REQUIRED VACCINATION CERTIFICATES. THESE WILL BE RETURNED. PETS WHOSE RABIES VACCINATIONS HAVE BEEN ALLOWED TO EXPIRE MAY BE SUBJECT TO A FINE IN ADDITION TO LICENSING & LATE FEES.
5. RABIES VACCINATION EXPIRATION DATE MUST BE LATER THAN NOVEMBER 1 OF THE YEAR FOR WHICH THE LICENSE IS BEING ISSUED. IF THE DATE ON YOUR PET'S CERTIFICATE IS EARLIER THEY MUST GET AN UPDATED BOOSTER AND VACCINATION CERTIFICATE OR YOU AND YOUR VET MUST SUBMIT FORM VPH-28. FORMS ARE AVAILABLE IN OUR OFFICE.
6. N.J.S. 4:19-15.5 REQUIRES YOU TO INDICATE ON THIS FORM IF ANY DOG IN YOUR POSSESSION HAS BEEN DEBARBED.
7. DOGS ARE NOT PERMITTED TO RUN AT LARGE, DISTURB THE PEACE WITH PROLONGED BARKING OR ALLOWED TO SOIL, DEFECATE OR COMMIT ANY NUISANCE ON PUBLIC PROPERTY OR ANY PRIVATE PROPERTY THAT YOU DO NOT OWN. OWNERS THAT PERMIT SUCH OFFENSES MAY BE SUBJECT TO A FINE.
8. LICENSE AND TAG WILL BE ISSUED/MAILED UPON RECEIPT OF THIS FORM, PROOF OF RABIES CERTIFICATE OR FORM VPH-28 & APPROPRIATE PAYMENT PAYABLE TO "BOROUGH OF ALPINE."
