Bids must be accompanied, in the case of corporations not chartered in the State of New Jersey, by proper certification that such corporation is authorized to do business in the State of New Jersey.

Every corporation or partnership submitting a bid shall accompany said bid with a statement setting forth the names and addresses of all stockholders in the corporation who own more than ten percent (10%) or more of the stock of any class, or of individual partners in the partnership who own a ten percent (10%) or greater interest therein. Said statement may also be submitted prior to the bid.

Any extra work, not originally contemplated under this Contract, shall be covered by a change order. In the event that such extra work involves labor or material for which a unit price has been bid, the aforementioned unit price shall be the maximum payable by the Borough therefor.
